

On the 28 day of September, 2018 at 16:47 (Specifically include facts constituting cause for arrest)

On Friday, September 28, 2018, at approximately 1422 hours, while conducting an investigation regarding a dispute between a customer and Home Depot employees located at 1694 West Indiantown Road (Home Depot) Jupiter, Florida 33458, a W/M later identified as, Clinton Selle (11/08/1976) began arguing with Ofc. Owen 331 and myself in regard to the location of our marked patrol vehicles.

Selle was stopped in a lane of travel in front of the business near the middle entry/exit doors but not at a stop sign. When Ofc. Owen instructed Selle to move along so we could continue to conduct our investigation, Selle refused to, and instead, continued to argue with us and started using profanity towards us. Ofc. Owen and I then turned our complete attention towards Selle and approached his vehicle (JUGP19). Ofc. Owen requested for Selle to display his driver's license and advised him that he was obstructing traffic and impeding our investigation. Selle at first refused to identify himself, but then after asking him multiple times, he told us his first name was Clinton.

Selle did not say his last name so Ofc. Owen walked to the rear of the vehicle and communicated the tag to Northcomm dispatch via police radio. Northcomm dispatch replied to us via police radio that the registered owner was a female (they did not look up the correct tag number initially). Selle kept putting his hands below the driver window where we were unable to see and despite our commands for him to keep his hands where we could see them, Selle did not comply and said, "no," along with locking the driver door. Selle then rolled his driver window up and again, put his hands below the window (we were on the driver side of the vehicle near the driver's window). Ofc. Owen commanded Selle to exit the vehicle because he was not identifying himself verbally or with a form of identification. He continued to keep one or at times both of his hands below the window where we could not see them. Ofc. Owen and I had our department issued firearms drawn on Selle at various times when he did not comply to keep his hands where we could

<p>see them and he still continued to not follow our commands.</p> <p>Ofc. Owen walked to the front passenger door of Selle's vehicle and opened it, instructing Selle to exit the vehicle. Selle opened the driver door, continuing to yell and curse at Ofc. Owen and myself while also yelling "Help!" There were groups of bystanders and customers standing nearby watching in front of the business as well as in the parking lot. I grabbed Selle's arm and escorted him to the rear of his vehicle while instructing him to turn away from me to face his vehicle. Selle started yelling as Ofc. Owen and placed him into handcuffs which were properly spaced and double locked. Selle was advised he was being arrested for resisting an officer without violence. Selle's driver's license was located after he was handcuffed. I ran the correct tag number through F/NCIC on my department issued computer and the vehicle was registered under Selle's name.</p> <p>Based on the facts above, I found probable cause to charge Clinton Selle with Resist an Officer without Violence because he did resist, obstruct or oppose Ofc. Owen 331 and myself, law enforcement officers of the Jupiter Police Department, in the execution of a legal process or in the lawful execution of a legal duty, without offering or doing violence to the person of such officer, contrary to Florida Statute 843.02. (1 DEG MISD).</p> <p>I also found probable cause to charge Clinton Selle with Disorderly Conduct because he did commit such acts as are of a nature to corrupt the public morals or outrage the sense of public decency, or affect the peace and quiet of persons who may witness them, or engaged in brawling or fighting, or engaged in conduct constituting a breach of the peace or disorderly conduct, contrary to Florida Statute 877.03. (2 DEG MISD).</p> <p>Selle was transported to JPD for paperwork, then to the Palm Beach County Jail without incident.</p>
