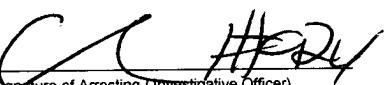
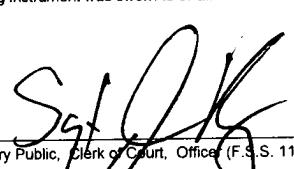
While speaking with staff they advised Riechers came to the Watershed to be admitted into the facility. Staff advised Riechers became belligerent and started to yell and scream at them. Staff advised they became so scared of Riechers they locked themselves inside of a room as he was threatening to harm them.

When officers arrived on scene Riecher was extremely belligerent and started to yell and scream at officers. Riechers refused to comply with officers orders to stop at which time Riecher kept yelling and screaming "someone stole my stuff" "I will sue you." When officers were speaking with Riecher there was an odor emanating from his body/facial area which based on my training and experience is known to be the odor of an unknown alcoholic beverage. As Riecher was yelling and refused to stop, it caused other onlookers including other staff to come to where Riecher was creating a disturbance causing an officer safety issue.

Based on the aforementioned Riecher was taken into custody at which time he was handcuffed (D/L, checked for spacing) and taken to BBPD for processing. It should be noted I was unable to positively identify Riecher as he stated he had no identification as he stated it was stolen on the way to Watershed and he lives out of state. An NCIC/FCIC check of records indicated no active warrants for Riecher.

Based on the aforementioned I find probable cause to charge Riecher with one count of Disorderly Intoxication pursuant to F.S. S. 856.011. Riecher was later TOT to PBCJ.
