D.U.I. PROBABLE CAUSE AFFIDAVIT

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On the above date at approximately 00:05hrs, I was dispatched to the scene of a motor vehicle crash without injuries at the intersection of Southern Blvd and Seminole Pratt Whitney Road, which is located in unincorporated Loxahatchee, Palm Beach County, Florida.

I arrived at the scene at approximately 00:19hrs. After my independent crash investigation, based on physical evidence, and witness statements, I determined that, at approximately 23:50hrs, the defendant, "COLETTE LAUREN SAMPLE", did indeed fail to stop for a red traffic signal at the same listed intersection and impact the driver side of V2 which was properly traveling eastbound with a green traffic signal. (See PBSO crash case #17-153115)

Witnesses, Jasmyne Croney, Taiyana Louis, Haley Bentrim, identified the defendant, to me, as the driver & sole occupant, of the 2003 black Toyota Corolla 4-door at the time of the crash. All witnesses completed a written sworn statement as to the events which transpired surrounding the crash and the driver of the vehicle that struck them.

D/S Tyrell Patt #8779 relayed to me that "SAMPLE" had articulable indicators of impairment, so he called for a DUI Unit to conduct a possible DUI investigation.

OBSERVATION OF DRIVER:

Upon making contact with the driver who was identified by her Florida driver license as "COLETTE LAUREN SAMPLE", I immediately detected an obvious and strong odor of an unknown alcoholic beverage emitting from her person and face area. This odor intensified as I spoke to Colette. She had glassy, glazed, and extremely blood shot eyes. Colette's speech was slurred, slow, thick, and at times difficult to understand. Colette's movements were slow and deliberate. Colette was lethargic in her movements. Colette had an unsteady gate while walking to my patrol vehicle and had difficulty following directions given to her. Colette was wearing a green blouse, blue jeans, and black sandals. All the clothing appeared slightly disheveled.

DRIVER'S STATEMENTS:

Pre-Miranda: Colette stated she was coming from "Clematis" where she had 2 drinks.

Colette consented to breath and made post Miranda admissions that she was driving after having 3 drinks consisting of Vodka & Cranberry and was involved in an accident.

ODORS:

A strong and obvious odor of an unknown alcoholic beverage was emitting from her person and face area which intensified as I spoke to Colette.

GENERAL OBSERVATIONS

SPEECH: Colette's speech was slurred, slow, and thick, and at times difficult to understand.

ATTITUDE: indifferent, polite, friendly, cooperative, apologetic

CLOTHING: Colette was wearing a green blouse, blue jeans, and black sandals.

MEDICAL/OTHER: none stated



HORIZONTAL GAZE NYSTAGMUS:

- LT EYE-LACK OF SMOOTH PURSUIT

Other Observations:

Colette would sway roughly in a side to side front to back pattern throughout the task. Colette did touch the tip of the pen as directed to positively identify the point to be tracked. Colette was reminded numerous times to track the pen with her eyes only. Colette failed to keep her head still while tracking the stimulus. She had VGN no LOC.

WALK & TURN:

I explained and demonstrated the instructions for the "Walk & Turn" to Colette who stated she understood. She would sway roughly in a side to side, front to back pattern throughout the demonstration phase. Colette could not maintain her balance while listening to instructions. She stepped out of the instructional stance during the demonstration to catch her balance. Colette started the task before being instructed to do so. Colette, on both passes, missed heel-to-toe steps. Colette performed an improper turn. She stumbled and turned other than which was demonstrated.

ONE LEG STAND:

I explained and demonstrated the instructions for the "One Leg Stand" to Colette who stated that she understood. Colette would sway roughly in a side to side, front to back pattern throughout the demonstration phase. Colette continued to sway while balancing on one leg. Colette failed to count out loud or by thousands as instructed. Colette put her foot down to regain balance numerous times before the 30 seconds had elapsed and switched legs.

FINGER TO NOSE:

I explained and demonstrated the instructions for the "Finger to Nose" task to Colette who stated that she understood. She would sway roughly in a side to side, front to back pattern throughout the demonstration phase. Colette's index finger did not touch the nose on 6 of 6 attempts. On L1 she touched the left nostril, on R1, R2, & R3 she touched her right nostril, on L2 and L3 she used the pad of her finger. Colette hesitated and searched for the tip of her nose prior to touching the tip. The sequence used for this task was L, R, L, R, R, L.

ROMBERG ALPHABET:

I explained and demonstrated the instructions for the "Rhomberg Alphabet" task to Colette who stated that she understood. She would sway roughly in a side to side, front to back pattern throughout the demonstration phase. Colette recited the the alphabet correctly to "X" then finished with "R, Z".




