On the above date and time I was dispatched to 7-Eleven located at 850 W Gateway Boulevard in							
reference to a possible CLS. While en-route, dispatch advised that that a male was unconscious in a white Dodge minivan in front of 7-Eleven and was slumped over the wheel. Sgt. Jean arrived on scene and

w/M later identified as W/M Colin Given via his FL driver's license (G150-104-97 122 0) belief the

The following task was demonstrated and explained to GIVEN who stated he understood. GIVEN did well with this task.

Based on the totality of the circumstances, GIVEN was placed under arrest for suspicion of Driving Under the Influence (D.U.I) at which time he was handcuffed (D/L, checked for spacing) and placed into the back seat of my patrol vehicle #4670. I did take GIVEN to the Palm Beach County Jail BAT facility at which time my twenty minute observation of GIVEN started at 1940 hrs. It should be noted while at the BAT Facility GIVEN advised that he also takes Trazadone every day. During the twenty minute observation period GIVEN did not regurgitate or take anything by mouth. Once the twenty minute observation period was over, I did ask GIVEN to submit to a lawful test of his breath to determine its alcohol content.

GIVEN agreed to the test and provided a BAC of .000 and .000. Suspecting that GIVEN is under the influence of chemical and/or controlled substance I did request a Urine sample from GIVEN. GIVEN did not understand several times, and was read implied consent numerous times before he advised he would submit to the test of his urine. Prior to the Urine test GIVEN was read his Miranda warnings on camera and advised he would not answer questions, in so Q & A was not done. After GIVENS handcuffs were removed in the BAT area, GIVEN gave the urine container back to officers and advised he refused to take the test. GIVEN was told that is refusal to take the test was now being considered a refusal at which time he said "that's fine just take me to jail, I am going anyway." Refusal time was 2020.

Based on the aforementioned I find probable cause to charge GIVEN with one count of Driving Under the influence (D.U.I.) pursuant to F.S.S. 316.193(2)c(1) and one count of Refusal to Submit to BAL (Urine test) pursuant to F.S.S. 316.1939. GIVEN later TOT to PBCJ.
