

<p>On 04-11-17, at 0934 hrs, I was dispatched to 4600 Military Trail #101 in reference to an Obscene/ Harassing Phone Calls incident. Upon arrival, I made contact with the victim, [REDACTED] and identified myself as a Jupiter Police Officer. [REDACTED] father was also on scene.</p>													
<p>[REDACTED] stated the following: For approximately 7 years, she was involved with the subject in this case, Colin N. Bove (DOB 01-24-89). The two dated on and off, and had a child together. For approximately 3 to 4 years now, [REDACTED] has not been involved with Colin; other than having contact for child sharing responsibilities. Since the break-up, approximately 4 years ago, Colin gets agitated every so often. [REDACTED] states that the two of them text and call back and forth as necessary, when it involves [REDACTED]. The agitation occurs by Colin speaking and texting vulgarities and obscenities to [REDACTED]. According to [REDACTED], Colin is "good for that about two times a year." Other than these occasional anger moments, Colin is fairly civil and cooperative with her. [REDACTED] called the police today, because she felt that this particular moment of anger, lasted an entire week long and involved very disturbing and aggressive actions and comments. She further stated that Colin has never acted this aggressive, or verbally abusive, in the past.</p>													
<p>The following, is documentation of Colin's actions over the last week (from 04-04-17 to 04-11-17): [REDACTED] stated that on 04-04-17, at approximately 2200 hrs, she was out with some friends at Jumby Bay in Jupiter - Abacoa Town Center. Colin showed up at Jumby Bay, parked outside near the bar/ restaurant, and watched her and her friends for about an hour, by looking through the restaurant window, from the outside. He eventually left the area. Colin was driving a black, Chevy Impala (which [REDACTED] knows to be Colin's vehicle). Soon after Colin left, [REDACTED] started receiving vulgar and obscene text messages from Colin's phone number (Cell #561-339-0530). She knew this to be his number because this was the phone number that he has used in the past, when communicating about</p>

<p>BOVE, COLIN NICHOLAS</p> <p>████████████████████ The text messages continued from 04-04-17, 2252 hrs, to 04-05-17, 0224 hrs. There were a total of 14 texts during this time frame, and ██████████ did not reply at any time.</p> <p>On 04-05-17, at 0716 hrs, the texts from Colin to ██████████ started again. Again, they were vulgar and obscene. There were a total of 19 texts up to 0253 (PM), until ██████████ texted with a reply. ██████████'s text only contained content referring to ██████████. Throughout the remainder of the day, on 04-05-17, Colin continued to text ██████████ with vulgarities and obscenities. There were a total of 46 texts from Colin, and ceased at approximately 0816 (PM). ██████████ also stated, that on 04-05-17, at approximately 1700 hrs, she was out to dinner with her father, Guillermo, at a restaurant in the Abacoa Town Center area - JJ Muggs. While at dinner, Colin drove by in his vehicle (the black, Chevy Impala) and was honking his horn as he drove around near the restaurant. Guillermo provided me with a statement as well, affirming the horn honking incident. ██████████ further stated that, after the horn honking, Colin proceeded to text her vulgar and obscene messages.</p> <p>On 04-06-17, at 0639 hrs, Colin started texting ██████████ again. The vulgar and obscene texting continued throughout the entire day, until approximately 0843 (PM). There were a total of 31 texts. ██████████ did not respond during this period of texting. ██████████ wanted me to be aware of one particular text from this period, that came in at 1225 (PM). The text stated "I promise u I am on the hunt...I will not let ur Nigga disrespect me." It was during this text that Colin had also sent ██████████ a picture. The picture shows a view from inside a vehicle, facing toward the direction of the Abacoa restaurant, Jumby Bay. A parking pass type stub can clearly be seen on the dashboard of the subject vehicle. ██████████ identified this vehicle to be the black Chevy Impala driven by Colin and stated that the picture was taken from the night of 04-04-17. I labeled the picture with "Picture #1" at the bottom of the photocopy.</p> <p>On 04-07-17, at 0021 hrs, Colin began texting ██████████ again. The obscene and vulgar texts continued, until approximately 0909 (PM), for a total of 44 texts. ██████████ responded one time during this texting period, and it was to make a statement regarding ██████████. Colin was apparently keeping ██████████ during ██████████ time to have ██████████.</p> <p>On 04-08-17, at 0834 hrs, Colin began texting ██████████ again, with vulgar and obscene statements. The texting continued on this day, through 0847 (PM), for a total of 27 texts. ██████████ responded 3 times, and again, it was in response to ██████████ status.</p> <p>On 04-09-17, at 0052 hrs, Colin started texting ██████████ with vulgar and obscene statements. The texting continued throughout the day until 1045 (PM), for a total of 132 texts. All of ██████████ responses were reference issues regarding ██████████. <p>point, during this texting incident, [REDACTED] stated 3 times "Leave me alone."</p> <p>On 04-10-17, at 0706 hrs, Colin started texting [REDACTED] again. He texted for a total of 4 times and the texting stopped at 1109 (PM).</p> <p>On 04-11-17, at 0703 hrs, Colin started texting [REDACTED] again. The texting continued until 0724 hrs that day, for a total of 5 times. Colin only texted one vulgar and obscene statement.</p> <p>All of the above documentation is related to text messaging. [REDACTED] stated that there were other incidents during the week, that did not involve texting, but that did involve Colin calling her phone, following her, hacking into her email and social media sites, and leaving a note on her property. I will describe those particular incidents below.</p> <p>Throughout the week period mentioned above, [REDACTED] has received notifications from Facebook, Instagram and other social medias, that her password had been changed. She also believes that her email account was hacked into as well. [REDACTED] stated that she did not change the passwords on her own. She also stated that, throughout the week, Colin was sending her pictures, as well as the texts. Some of those pictures were only accessible to [REDACTED] and were located in the various social media sites mentioned. [REDACTED] also received numerous phone calls from Colin, during this time frame. She received a total of 104 calls from Colin's phone number, along with 5 calls from a "no caller ID" number. The "no caller ID" calls were received after [REDACTED] advised Colin that she was blocking his number. [REDACTED] stated there were several nights, from 04-04-17, that she observed Colin's vehicle driving around the area of her residence and in the rear alleyways of her residence. Generally, there would be no reason for a vehicle to travel in these alleyways, unless it was a resident. The night prior to [REDACTED] reporting this incident (04-10-17), she noticed Colin's vehicle driving around in the area. On the morning of 04-11-17, [REDACTED] found a note at her residence, left on the patio. The note was one that was written to him, from [REDACTED], back when the two were a couple. [REDACTED] stated that there was nobody else that could've been in possession of the note. She felt that Colin was on her property and that was concerning to her. [REDACTED] further stated, based on past experiences with Colin, and the intensity and anger of this particular incident, she is tremendously concerned that Colin may jeopardize her safety. [REDACTED] usually blocks Colin's phone number when she has custody of [REDACTED], so she is not harassed, but has to leave herself available when the child is with Colin.</p> <p>Based on my investigation, I found the following: On 04-11-17, [REDACTED] provided me with numerous pieces of documentation, showing the interaction between her and Colin, over the time period of 04-04-17 to 04-11-17. There is documentation of over 400 text messages (most of which are vulgar and obscene), photographs sent by Colin and photographs obtained at Colin's residence. All of these items were placed into the JPD</p>



Evidence Section. On 04-11-17, at approximately 1253 hrs, I attempted to make contact with Colin at his residence (6122 Garrett St. - The Heights of Jupiter). Colin was not home, but his father answered the door. His father stated that he was currently at school, but that he would relay any messages to Colin that needed to be relayed. I also called Colin and advised him that I needed to speak with him. Over the next several days, Colin did not make any attempts to call or contact me. On 04-14-17, at approximately 0830 hrs, I again visited Colin's residence. Upon arriving, I noticed a black Chevy Impala (FL tag #J307AT) in the driveway, and I noticed a male subject standing inside, at the front door. I parked my vehicle, and approached the residence. I stopped midway on the driveway and verbally communicated with the male subject at the front door. The male (identified as Colin; by photographs provided to me by [REDACTED]) stated "Can I help you?" I stated that I needed to speak with him reference an incident involving [REDACTED]. Colin then stated, "Am I under arrest?" I stated "No" and he stated "I don't need to talk to you then." Colin then proceeded to close the door to the residence and stayed inside. As I stood in the driveway, I noticed the black Impala to have a parking pass type stub, inside the vehicle, on the dashboard. It looked identical to the one in the photograph [REDACTED] provided to me, from the night she was being followed by Colin, at Jumby Bay. I took photographs of the parking pass, the vehicle and the residence, and left the scene. A little later in the day, at approximately 1010 hrs, I called Colin again, to explain why I was at his residence. At the moment of connection with Colin, on the phone, he immediately started talking and told me "don't interrupt me, I want to say what I have to say." I attempted to identify myself to him, prior to him making any statements. Colin was very angry on the phone and demanded to know why there were police on his driveway and why they were taking pictures. When Colin eventually stopped speaking, I advised him that I was the one that was on his driveway. He immediately told me that he was not talking to me and to stop harassing him. He then hung the phone up as I began to speak. I have not attempted contact with Colin, since this incident. I did however, make contact with [REDACTED] again, a bit later in the day. I wanted to follow up with [REDACTED] and find out if any other incidents have occurred. [REDACTED] advised me that Colin has still continued to text her. She also stated that he has been sending her photographs of wedding rings and stating that they "belong together."

As of today's date, 04-20-17, I am continuing to investigate this incident. On 04-20-17, at approximately 1030 hrs, I spoke with [REDACTED] via phone line. [REDACTED] stated that Colin has continued to text her with obscenities and vulgarities. She stated he has "eased up" on the aggressive behavior, but she is still concerned for her safety and well being.

Evidence has shown that Colin has engaged in a course of conduct directed at [REDACTED], which has been causing substantial emotional distress to her and does not serve any legitimate purpose. Colin has also willfully, maliciously and repeatedly followed, harassed and stalked [REDACTED], through a variety of methods and means.

On 04-11-17, at 0934 hrs, I was dispatched to 4600 Military Trail #101 in reference to an Obscene/ Harassing Phone Calls incident. Upon arrival, I made contact with the victim, [REDACTED] and identified myself as a Jupiter Police Officer. [REDACTED] 's father was also on scene, [REDACTED]

[REDACTED] stated the following: For approximately 7 years, she was involved with the subject in this case, Colin N. Bove (DOB 01-24-89). The two dated on and off, and had a [REDACTED]. For approximately 3 to 4 years now, [REDACTED] has not been involved with Colin; other than having contact for child sharing responsibilities. Since the break-up, approximately 4 years ago, Colin gets agitated every so often. [REDACTED] states that the two of them text and call back and forth as necessary, when it involves [REDACTED], [REDACTED]. The agitation occurs by Colin speaking and texting vulgarities and obscenities to [REDACTED]. According to [REDACTED], Colin is "good for that about two times a year." Other than these occasional anger moments, Colin is fairly civil and cooperative with her. [REDACTED] called the police today, because she felt that this particular moment of anger, lasted an entire week long and involved very disturbing and aggressive actions and comments. She further stated that Colin has never acted this aggressive, or verbally abusive, in the past.

The following, is documentation of Colin's actions over the last week (from 04-04-17 to 04-11-17): [REDACTED] stated that on 04-04-17, at approximately 2200 hrs, she was out with some friends at Jumby Bay in Jupiter - Abacoa Town Center. Colin showed up at Jumby Bay, parked outside near the bar/ restaurant, and watched her and her friends for about an hour, by looking through the restaurant window, from the outside. He eventually left the area. Colin was driving a black, Chevy Impala (which [REDACTED] knows to be Colin's vehicle). Soon after Colin left, [REDACTED] started receiving vulgar and obscene text messages from Colin's phone number (Cell #561-339-0530). She knew this to be his number because this was the phone number that he has used in the past, when communicating about the child. The text messages continued from 04-04-17, 2252 hrs, to 04-05-17, 0224 hrs. There were a total of 14 texts during this time frame, and [REDACTED] did not reply at any time.

On 04-05-17, at 0716 hrs, the texts from Colin to [REDACTED] started again. Again, they were vulgar and obscene. There were a total of 19 texts up to 0253 (PM), until [REDACTED] texted with a reply. [REDACTED] 's text only contained content referring to [REDACTED]. Throughout the remainder of the day, on 04-05-17, Colin continued to text [REDACTED] with vulgarities and obscenities. There were a total of 46 texts from Colin, and ceased at approximately 0816 (PM). [REDACTED] also stated, that on 04-05-17, at approximately 1700 hrs, she was out to dinner with her father, Guillermo, at a restaurant in the Abacoa Town Center area - JJ Muggs. While at dinner, Colin drove by in his vehicle (the black, Chevy Impala) and was honking his horn as he drove around near the restaurant. Guillermo provided me with a statement as well, affirming the horn honking incident. [REDACTED] further stated that, after the horn honking, Colin proceeded to text her vulgar and obscene messages.

On 04-06-17, at 0639 hrs, Colin started texting [REDACTED] again. The vulgar and obscene texting continued throughout the entire day, until approximately 0843 (PM). There were a total of 31 texts. [REDACTED] did not respond during this period of texting. [REDACTED] wanted me to be aware of one particular text from this period, that came in at 1225 (PM). The text stated "I promise u I am on the hunt....I will not let ur Nigga disrespect me." It was during this text that Colin had also sent [REDACTED] a picture. The picture shows a view

from inside a vehicle, facing toward the direction of the Abacoa restaurant, Jumby Bay. A parking pass type stub can clearly be seen on the dashboard of the subject vehicle. [REDACTED] identified this vehicle to be the black Chevy Impala driven by Colin and stated that the picture was taken from the night of 04-04-17. I labeled the picture with "Picture #1" at the bottom of the photocopy.

On 04-07-17, at 0021 hrs, Colin began texting [REDACTED] again. The obscene and vulgar texts continued, until approximately 0909 (PM), for a total of 44 texts. [REDACTED] responded one time during this texting period, and it was to make a statement regarding the child. Colin was apparently keeping the child, during [REDACTED]'s time to have the child.

On 04-08-17, at 0834 hrs, Colin began texting [REDACTED] again, with vulgar and obscene statements. The texting continued on this day, through 0847 (PM), for a total of 27 texts. [REDACTED] responded 3 times, and again, it was in response to the child status.

On 04-09-17, at 0052 hrs, Colin started texting [REDACTED] with vulgar and obscene statements. The texting continued throughout the day until 1045 (PM), for a total of 132 texts. All of [REDACTED]'s responses were reference issues regarding [REDACTED]. At one point, during this texting incident, [REDACTED] stated 3 times "Leave me alone."

On 04-10-17, at 0706 hrs, Colin started texting [REDACTED] again. He texted for a total of 4 times and the texting stopped at 1109 (PM).

On 04-11-17, at 0703 hrs, Colin started texting [REDACTED] again. The texting continued until 0724 hrs that day, for a total of 5 times. Colin only texted one vulgar and obscene statement.

All of the above documentation is related to text messaging. [REDACTED] stated that there were other incidents during the week, that did not involve texting, but that did involve Colin calling her phone, following her, hacking into her email and social media sites, and leaving a note on her property. I will describe those particular incidents below.

Throughout the week period mentioned above, [REDACTED] has received notifications from Facebook, Instagram and other social medias, that her password had been changed. She also believes that her email account was hacked into as well. [REDACTED] stated that she did not change the passwords on her own. She also stated that, throughout the week, Colin was sending her pictures, as well as the texts. Some of those pictures were only accessible to [REDACTED] and were located in the various social media sites mentioned. [REDACTED] also received numerous phone calls from Colin, during this time frame. She received a total of 104 calls from Colin's phone number, along with 5 calls from a "no caller ID" number. The "no caller ID" calls were received after [REDACTED] advised Colin that she was blocking his number. [REDACTED] stated there were several nights, from 04-04-17, that she observed Colin's vehicle driving around the area of her residence and in the rear alleyways of her residence. Generally, there would be no reason for a vehicle to travel in these alleyways, unless it was a resident. The night prior to [REDACTED] reporting this incident (04-10-17), she noticed Colin's vehicle driving around in the area. On the morning of 04-11-17, [REDACTED] found a note at her residence, left on the patio. The note was one that was written to him, from [REDACTED], back when the two were a couple. [REDACTED] stated that there was nobody else that could've been in possession of the note. She

felt that Colin was on her property and that was concerning to her. [REDACTED] further stated, based on past experiences with Colin, and the intensity and anger of this particular incident, she is tremendously concerned that Colin may jeopardize her safety. [REDACTED] usually blocks Colin's phone number when she has custody of [REDACTED], so she is not harassed, but has to leave herself available when the child is with Colin.

Based on my investigation, I found the following: On 04-11-17, [REDACTED] provided me with numerous pieces of documentation, showing the interaction between her and Colin, over the time period of 04-04-17 to 04-11-17. There is documentation of over 400 text messages (most of which are vulgar and obscene), photographs sent by Colin and photographs obtained at Colin's residence. All of these items were placed into the JPD Evidence Section. On 04-11-17, at approximately 1253 hrs, I attempted to make contact with Colin at his residence (6122 Garrett St. - The Heights of Jupiter). Colin was not home, but his father answered the door. His father stated that he was currently at school, but that he would relay any messages to Colin that needed to be relayed. I also called Colin and advised him that I needed to speak with him. Over the next several days, Colin did not make any attempts to call or contact me. On 04-14-17, at approximately 0830 hrs, I again visited Colin's residence. Upon arriving, I noticed a black Chevy Impala (FL tag #J307AT) in the driveway, and I noticed a male subject standing inside, at the front door. I parked my vehicle, and approached the residence. I stopped midway on the driveway and verbally communicated with the male subject at the front door. The male (identified as Colin; by photographs provided to me by [REDACTED]) stated "Can I help you?" I stated that I needed to speak with him reference an incident involving [REDACTED]. Colin then stated, "Am I under arrest?" I stated "No" and he stated "I don't need to talk to you then." Colin then proceeded to close the door to the residence and stayed inside. As I stood in the driveway, I noticed the black Impala to have a parking pass type stub, inside the vehicle, on the dashboard. It looked identical to the one in the photograph [REDACTED] provided to me, from the night she was being followed by Colin, at Jumby Bay. I took photographs of the parking pass, the vehicle and the residence, and left the scene. A little later in the day, at approximately 1010 hrs, I called Colin again, to explain why I was at his residence. At the moment of connection with Colin, on the phone, he immediately started talking and told me "don't interrupt me, I want to say what I have to say." I attempted to identify myself to him, prior to him making any statements. Colin was very angry on the phone and demanded to know why there were police on his driveway and why they were taking pictures. When Colin eventually stopped speaking, I advised him that I was the one that was on his driveway. He immediately told me that he was not talking to me and to stop harassing him. He then hung the phone up as I began to speak. I have not attempted contact with Colin, since this incident. I did however, make contact with [REDACTED] again, a bit later in the day. I wanted to follow up with [REDACTED] and find out if any other incidents have occurred. [REDACTED] advised me that Colin has still continued to text her. She also stated that he has been sending her photographs of wedding rings and stating that they "belong together."

As of today's date, 04-20-17, I am continuing to investigate this incident. On 04-20-17, at approximately 1030 hrs, I spoke with [REDACTED] via phone line. [REDACTED] stated that Colin has continued to text her with obscenities and vulgarities. She stated he has "eased up" on the aggressive behavior, but she is still concerned for her safety and well being.

Evidence has shown that Colin has engaged in a course of conduct directed at [REDACTED], which has been

causing substantial emotional distress to her and does not serve any legitimate purpose. Colin has also willfully, maliciously and repeatedly followed, harassed and stalked [REDACTED], through a variety of methods and means. I request the State charge Colin with Stalking, per F.S.S. 784.048(2).

On 04-21-17, at approximately 0915 hrs, I made contact with Colin at his residence. Colin was advised that there was probable cause for his arrest and invited us into his residence. At 0922 hrs, I placed Colin under arrest for the above mentioned charge. He was processed and transported to PB County Jail without incident.
