committed the below acts in my presence. was observed by **OFFICERS** _____ who told _____ that he/she saw the arrested person committ the below acts.

confessed to **OFFICERS** _____ admitting to the below facts. was found to have committed the below acts, resulting from my (described) investigation.

On the **18** day of **October**, **2017** at **01:20** (Specifically include facts constituting cause for arrest.)

On 10/18/2017 at 0120 hours, Officers Woods, Reed, Kopplin, and I were on patrol in the 200 block of SW 12th Avenue. This area is well known and documented for narcotics activity and arrest. During patrol we observed a white male, who was later identified as Colsson Douglas Ford, standing next too a known prostitute, B/F Alexandra Dominique. It should be noted the aforementioned Officers have had multiple contacts with Dominique in reference to drugs and prostitution.

Officers went to make a consensual encounter with the subjects and could see choreboy in plain view sticking out of Dominique`s jacket pocket. Based on my training and experience, I know choreboy is commonly used to smoke crack-cocaine. When Officers Reed and Kopplin approached them, Ford had his left hand clinched (common way to conceal narcotics from Officers view) and was attempting to shove an unknown item in his front left pocket. Officers ordered Ford to stop, and open his clinched left hand. Ford opened his hand and dropped a clear cigarette wrapper containing a white powdery substance. Officer Kopplin asked Ford what the substance was at which time he stated, " It is powder."

He further advised that he had crack cocaine in his left front pocket. He was immediately placed in handcuffs. While searching Ford, I located a white rocklike substance in his front left pocket, which broke into multiple pieces as I was trying to remove it. The substance was field tested by Officer Woods, using a Quick Check cocaine test kit and it produced positive reaction for crack-cocaine. The white powder was also tested and produced a positive reaction for cocaine.

Based on the facts above, Colsson D Ford is being charged with two counts of possession of cocaine in accordance with F.S.S. 893.13(6 A).
