

On the 27 day of July, 2018 at 01:24 (Specifically include facts constituting cause for arrest)

On 07/27/2018 I observed a silver Mazda bearing FL tag#CNPJ89 with an expired registration sticker at NW 2nd Ave and NW 2nd St to make a right turn onto NW 2nd Ave. As the vehicle travelled northbound on NW 2nd Ave veered off to the right of its lane and even stopped in the lane before making a right turn onto NW 3rd St. The vehicle once again veered of the right of its lane driving onto the grassy median and then turned into the parking lot of 150 NW 2nd St where I conducted the traffic stop on the vehicle. I then met with the driver and only occupant Constance Okun and advised her the reason for the stop. Okun stated that she was trying to find the Turnpike and had her driver's license and insurance ready for me. I then asked her for her documentation which she was able to provide. I then asked where she was coming from and she stated Mizner Park and she was going home. I then asked her if she had anything to drink and she stated no. While speaking with her I could smell a strong odor of an alcoholic beverage emanating from her person, her eyes were glassy and bloodshot, and she was slurring her speech.

Ofc Alvarez arrived on scene as my backup. I asked Okun to exit the vehicle and based on my observations I then asked her if she would submit to the roadside sobriety tasks to dispel my alarm that she was under the influence. I then walked her over to a well-lit area and asked her if she had any medical problems or medical issues that would prevent her from doing the tasks. Okun stated that she had no physical or medical problems that would prevent her from doing the tasks. The tasks that were conducted were the Walk and Turn, One Leg Stand, Finger to Nose, and the Rhomberg Alphabet.

The first SFST was the Walk and Turn. Okun failed to maintain the starting position. She failed to count as instructed. As she walked the line she failed to keep her feet heel to toe. She walked 8 steps forward and then 10 steps backward. She also swayed during the task and stepped off the line while trying to keep her balance.

The second SFST was the One Leg Stand. She failed to keep her foot six inches off the ground. She started the task before being told to begin the task. When she first began the task, she raised her right hand for balance and she counted improperly during the task.

The third SFST was the Finger to Nose (L-R-L-R-R-L). On the first left, she touched under her nose. On the first right she touched the right side of her nose. The second left she touched under her nose. The second right she touched under her nose. On the third right, she touched the right of her nose. On the third left she touched left side of her nose.

The fourth SFST was the Rhomberg Alphabet which she was able to recite properly. Based on my investigation I placed Okun under arrest for DUI. Ofc. Alvarez searched Okun and I then transported her to BRPD. Search incident to arrest Okun advised that she had marijuana inside of her vehicle and it was located inside of the vape pen. Ofc Alvarez located the vape pen and I tested the oil with a Quick Check marijuana test kit (one use only) and the liquid turned purple indicating the presence of THC. Ofc Alvarez also located a glass pipe with marijuana residue inside the vehicle as well as a baggy of ecstasy in a backpack in the backseat of the vehicle. See her supplement for further details.

Ofc. Reissi responded as my Breath Test operator and we both conducted the twenty-minute observation. Okun was then taken into the BAT room where she was asked to provide a breath sample. Okun provide two breath samples of .073 and .073. Okun provided a urine sample. I also read Okun her Constitutional Warnings which she advised she understood and she would answer my questions without an attorney present. See DUI influence report. Okun claimed ownership of the vape pen and the hash oil that was inside of the vape pen. Okun advised that she used the vape pen tonight while she was out at the bar. Okun advised that the backpack that belonged to her friend and she had no idea that the bag of ecstasy was left in her car. Okun advised that she though that the baggy possibly contained either cocaine or ecstasy but it didn't belong to her. Okun stated that she only knew what it was because she knew her friend uses that kind of drug. I placed the ecstasy into evidence as found property. The marijuana vape pen and glass pipe were placed into evidence at BRPD.

Constance Okun is being charged under F.S.S. 316.193(1) for DUI. She is also being charged under F.S.S 893.13(6a) for possession of Hash oil and for possession of paraphernalia under F.S.S 893.147(1B). Okun was also issued a citation under F.S.S 316.074(1) violation of a traffic control device. Okun was transported to Palm Beach county jail for final disposition. Okun's vehicle was towed by Westway.
