I asked if the driver had been drinking or used any drugs, which he stated that his friend forced him to smoke marijuana. I asked the driver what medical problems and/or previous injuries they had, which he stated none. I asked what medications he take and he stated he takes Lithium, Trileptal, and Zoloft.

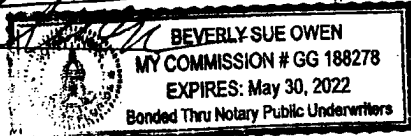

Other Observations:

Vertical Gaze Nystagmus lack of smooth pursuit in both eyes, distinct and sustained nystagmus at maximum deviation, on set nystagmus prior to 45 degrees. would follow the tip of my index finger with entire head.

WALK & TURN:

I positioned Mr. Lankford on the center line of a roadway, which was on a smooth and level surface, free of any debris and well lit by the Florida sun. I instructed the Mr. Lankford to place his left foot on the line and his right foot in front of the left touching heel to toe. I instructed him that he was to keep his hands at his side and stay in this position until I instructed him to do otherwise. I instructed him to walk nine heel to toe steps counting out loud, while watching his feet. On the ninth step he was to keep his front foot on the line and use his back foot, in a series of small steps, to turn around before walking nine heel to toe steps the opposite direction counting out loud and watching his feet. I demonstrated the task while I was verbally instructing him in the proper way to complete the task. During the task, I observed the driver swayed while balancing, started too soon, stops walking to steady self, did not touch heel to toe during entire exercise, stepped off the center line of the roadway and walked parallel to the center of the roadway, Used arms to maintain balance (+6"), did not turn properly(loses balance while turning(staggers or stumbles, turns other way than I explained.) Incorrect number of steps, he would crouch/ slouch over and walk at the same time during the exercise, Could not perform task.

ONE LEG STAND:

I placed Mr. Lankford with his feet together and arms at his side. I demonstrated the task as I verbally instructed him to raise one of his feet approximately six inches off of the ground, point his toe towards D/S Gubish's marked PBSO patrol vehicle, look at the raised foot, and count out loud 1001, 1002, 1003 and so on until told to stop. I asked him if he understood the instructions and demonstration I provided. After Mr. Lankford stated he understood my instructions, the task was performed. While Mr. Lankford stood in the instructional position, I observed he started too soon and swayed while standing stationary. While raising his foot he swayed while balancing, put foot down (within 30 seconds), would stumble backwards to maintain balance, could not do task (put foot down three times).

FINGER TO NOSE:

I placed Mr. Lankford with his feet together and arms at his side with his index fingers pointed. I then instructed and demonstrated to Mr. Lankford to tilt his head back and close his eyes during the exercise. I explained to Mr. Lankford that when I tell him to bring the hand directly upward, touching the tip of his nose with the tip of his index finger and immediately bring his hand back down to his side. I then started the exercise with the following sequence - Left, Right, Left, Right, Right, Left. I observed Mr. Lankford to sway side to side and forward to back, touch the center of his nose and not the tip of his nose, opened eyes multiple times, would lean head forward instead of backwards.
