On 8/19/16 at approximately 1512 hours I responded to 22365 Sea Bass Drive, Boca Raton in reference to a domestic disturbance complaint. Upon arrival, I met with Cori Cimber and Michael Tetreault and the following information was gathered.

Tetreault informed me that he resides at the above location. On the above date and approximate time his girlfriend Cimber, had come over to his house. Tetreault stated that upon her arrival she very agitated with him because she believed that he was seeing another woman. When she arrived, the first thing she did was throw a bag at him. The bag struck him in the chest area. The bag contained some of his personal effects along with some money. After she threw the bag at him, she began to strike him with her hand and she also bit him.

I observed numerous scratch marks across Tetreault chest. Tetreault also had a scratch on his left arm inside the elbow area. In addition to the scratch marks, Tetreault had two bite marks. One bite mark was on the outside upper thigh of his right leg. The other bite mark was on his back in the center of his back. Tetreault stated he was attacked by Cimber when he was lying down on his bed. Tetreault stated that he was in a defensive posture while Cimber was attacking him. Tetreault stated that at no time did he strike Cimber during the physical altercation. Tetreault stated that this entire altercation only lasted about two minutes.

I questioned Cimber about the above incident. Without hesitancy, Cimber stated that she came to Tetreault house because she was upset with him because she believed that he was cheating on her. Cimber stated that she did scratch Tetreault across his chest and arm. Cimber also stated that she did in fact bite Tetreault twice; once on the right leg and once on the back. Cimber denied that Tetreault ever struck her during the altercation.

Based upon the above investigation, it was determined that Cimber was the primary aggressor and that Tetreault was the victim. Cimber did actually and intentionally strike Tetreault against the will of Tetreault and Cimber did intentionally cause bodily harm to Tetreault contrary to Florida Statute 784.03(1)(a)(1). As a result Cimber was arrested for domestic battery against Tetreault due to the romantic relationship that Cimber and Tetreault had for the last four years.
