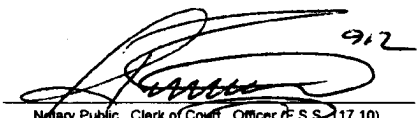

On the above date and time, while I was on patrol in the area of 1700 N Congress Ave in the city of Boynton Beach FL, I heard a loud crash. I then observed a dark gray GMC pick up truck bearing FL tag CFQ3407 in the north bound lanes of N Congress Ave and Renaissance Dr, facing south bound. Approximately 30ft north of Renaissance Dr. The GMC pick up had fresh damage to the drivers side drivers door as well as the rear passenger tire was flat. I also observed a unknown black vehicle leaving the scene traveling East on Renaissance Dr away from N Congress Ave. As I made contact with the driver of the GMC who stated that he was not injured. I asked him if he knew what type of vehicle struck his and he stated no. Additional Boynton Beach Police Units arrived on scene and tracked down the vehicle that left the scene which was located at 1690 Renaissance Commons Blvd on the 4th floor of the parking garage. It should be noted that where the defendants vehicle was located was approximately 3 blocks from where the crash occurred. The vehicle had heavy front end damage. It should be noted that leading from the crash to the vehicle was a debris trail which came off of the suspect vehicle as it fled the scene. Also While on scene I observed a front grill of a Mercedes Benz. The suspect vehicle which was a Mercedes Benz bearing FL tag JRAE34 that was located was missing the front grill to the vehicle. Dispatch advised officers that the owner of the vehicle lived at 1690 Renaissance Commons Blvd Apt 1407. They made contact with W/F Kraker, Cori who stated to them that she was just involved in a vehicle accident and was not injured.

Once I completed my initial investigation on the original crash scene, I met with Cori by her black Mercedes Benz Bearing FI tag JRAE34. When I made contact with Cori, I asked if she had any injuries and she stated that she did not. I read Cori Kraker her Miranda rights which she waved and provided me with the following confession; I asked her if she was involved in a vehicle crash and she stated yes. She went on to say that she remembers turning off of N Congress Ave onto Renaissance Dr and striking a dark colored pick up truck. When she hit the truck she fled the scene and parked her vehicle on the 4th floor of 1690 Renaissance Commons Blvd and walked to her Apt 1407. I asked Cori if she stopped and made contact with the driver of the pick up truck and she stated no. She also stated that she did not render any aid nor did she provide any information to the driver. I also asked Cori why she left the scene and entered her apartment instead of staying with her vehicle. She stated that she was scared and knew she should have remained on scene. It should be noted that Cori acknowledged that she was in fact the one driving the black Mercedes Benz which had fresh damage to the front end of the vehicle. Also the keys to her vehicle were located in her apartment where officers originally located her.

From the facts stated above, I find that PC does exist pursuant to FSS 316.062 Leaving the scene of an accident W/O injuries.
