(Specifically include facts constituting cause for arrest.)</p> <p>I responded to 400 N Congress Avenue in the Town of Lake Park Florida in reference to a shoplifting call that occurred at the Kohl's Department store . Prior to arrival , dispatch advised that the caller stated the male left the area in the parking lot and left the area in a white (kia)vehicle bearing tag (Z28EZI). D/S Turpin #7667 observed the vehicle traveling South on Congress Avenue and conducted a Traffic stop on the vehicle which came to a complete stop at 500 North Congress Ave (TARGET) parking lot. D/S Turpin #7667 was able to get the loss prevention officer to identify the suspect and took possession of the stolen merchandise . Calcagni was arrested for Retail Theft check for double lock and proper fit , and secured in my vehicle . I transported Calcagni to the Kohl's Department store to meet with Loss Prevention .</p> <p>Upon arrival , I made contact with loss prevention officer, Elgie Morton who stated he observed an adult male on surveillance CCTV in the mens department . The male later identified as , Cory Calcagni from his Florida Drivers License traveled to the mens section of the store where he selected various mens (NIKE) clothing . Calcagni stacked the clothing on a rack in the department and left the department . Calcagni then walked to the house wares Department and selected a Nike book bag . Calcagni returned to the area where he left the other Nike merchandise , opened the book bag and concealed the Nike clothing inside . Calcagni placed the filled book bag on his back , and proceeded to the front of the store passing all points of sale without any attempt to pay for the merchandise worth \$585.00 concealed in the book bag . Calcagni then exits the store and was approached by loss prevention Morton who identified himself and asked Calcagni to walk to the the loss prevention office as he refused . Calcagni took off from the scene with the merchandise before getting into a vehicle leaving the scene .All merchandise was recovered by Loss prevention</p> <p>Based on the above facts and described investigation , I found probable cause to arrest Cory Calcagni for Retail theft pursuant to Florida Statute 812.014 (2C1)</p>
