On 11/10/19 at approximately 204 hours I responded to the parking lot in front of 811 University Blvd, Jupiter, FL (Sophia Apartments) in reference to a verbal altercation between the onsite security guard, WM Richard A Graham 3/26/53, and two other males. While en-route, Nortcom advised there was a heated verbal altercation taking place and possibly turning physical.

Upon arrival, I observed a white SUV (belonging to Graham) parked in the driving lane in front of the above location. Graham and two other males were standing at the back of the vehicle and appeared to be in a verbal altercation. As I pulled up in my marked patrol vehicle, Graham approached me and stated that the other two males, later identified as WM Cory B Hanlon 5/20/86 and WM Louis C Devaleix 1/19/81, had driven onto the property in a blue golf cart which was now parked across from the above location. They were playing loud music and yelling so he approached them to ask that they turn the music down and be quite. During his conversation with them, they became verbally aggressive and got in his face. At one point the male later identified as Hanlon, got so close to him that he put his hand out and asked him to step back. Hanlon then pushed his hand away. Graham then called the police. He stated that he believed they were both intoxicated.

After speaking with Graham, I approached Hanlon and Devaleix and requested they provide me with identification as part of my investigation. Hanlon was immediately noncompliant and refused to identify himself. As I was speaking with him, I noticed his speech was slurred and thick tongued, and his faced was flushed. Hanlon was advised that he must identify himself and he still refused. I then placed him handcuffs that were double locked and checked for spacing per policy. During this process, he began yelling and tensed his arms. After the handcuffs were secured on his wrists, he continued to tense and pull away. It should be noted that he had a strong odor of an unknown alcoholic beverage coming from his person that became stronger as he was yelling. During a search incident to arrest, Hanlon was identified by his Florida Driver's Licenses that was found in his wallet.

Based on the above testimony and my personal interaction with Hanlon, I find probable cause exist to arrest Cory B Hanlon because he was intoxicated and endangered the safety of another person or property, or was intoxicated or drank an alcoholic beverage in a public place or in or upon a public conveyance and caused a public disturbance, contrary to Florida Statute 856.011(1).

In addition Hanlon did resist, obstruct or oppose *(PFC J. Flesch #348), a law enforcement officer of the *(Jupiter Police Department), in the execution of a legal process or in the lawful execution of a legal duty, without offering or doing violence to the person of such officer, contrary to Florida Statute 843.02.

Hanlon was advised he was under arrest for the above charges. He was transported to the Jupiter Police Department for processing. While in the holding area, he continued to be noncompliant, argumentative, and shouted. He was ultimately booked into PBCJ under the above charges.

After taking Hanlon into custody, I requested Devaleix provide me with identification. He was compliant and identified himself with a Florida Driver's License. Devaleix also appeared intoxicated. His eyes were bloodshot and glassy and he also had the odor of an unknown alcoholic beverage coming from his person that became stronger as he spoke. It was determined that he had not been involved in any criminal activity and was released on scene.

It should be noted that Hanlon advised he is a former North Carolina Trooper. His employement status there was unable to be verified.
