
In the city of Boynton Beach, within the county of Palm Beach, I, Officer D. Whitefield, was dispatched to Sweetwater Bar and Grill, 1507 S Federal Hwy, in reference to a disturbance.

Upon arrival, I met with employee, Robert Brown who advised the defendant, w/m Cory Camp, was being aggressive towards other employees and customers. Brown stated while Camp was standing out outside the bar, he picked up a glass and threw it at the ground. When Brown went outside to check on him, Camp became aggressive and started yelling at him. Due to Camp's behavior, Brown told him to leave and locked the front door to the establishment. After locking the door, Camp became irate and started pounding on the front door with his hands and feet. Brown stated that is when he decided to call 911 to help assist Camp off the property.

After speaking with Brown, I located Camp in the public parking deck attempting to fight another group of males. Camp was clearly under the influence of alcohol and/or drugs and kept walking towards people trying to get them to fight. Once Camp was detained, he began to yell and scream that what we were doing to him was "bullshit". Camp refused to get into my patrol vehicle and had to be pulled in from the opposite side. From observation and the statement given by Brown, Camp was intoxicated to the point he was placing himself and other people in danger while in a public place.

Based on the aforementioned, I find probable cause to charge Cory Camp with one count of Disorderly Intoxication in violation of F.S.S. 856.011. He was arrested and transported to BBPD for processing and later transported to PBCJ without incident.
