

On Monday March 5, 2018 at approximately 01:40 hours while conducting routine patrol in a Palm Beach County Sheriff's Office fully marked vehicle in the area of 14000 Greenbriar Boulevard, I observed a 2007 black Jeep Wrangler traveling at a high rate of speed on the roadway. Due to my training and experience it was immediately apparent that the driver was traveling over the posted speed limit. I traveled behind the driver in an effort to pace his speed. I estimate that I traveled behind the Jeep approximately 3/10ths of a mile. The driver was traveling well over 55 MPH in a 35 zone. The Jeep was traveling around a curved roadway in an erratic manner. The driver crossed over the center lane to the left of the roadway into the opposite lanes of travel. The driver's front and rear side of the vehicle crossed over the double lines as he failed to maintain his lane of travel. As the driver over corrected to get out of the opposite lanes of travel, the Jeep veered to the right of the curve slightly off of the roadway as he made the turn causing the vehicle to swerve. The driver of the Jeep did not pull the vehicle over once I activated my lights and sirens. It should be noted that this area is not well lit. Therefore, if vehicles were traveling around the curve towards the Jeep they would have been impacted. The final stop was on Wellington Trace and Belmont. Upon making the approach to the driver's side of the vehicle, I could smell the odor of an unknown alcoholic beverage emanating from the open window. At the time of the stop DS Pointu arrived as a backup unit and made contact with the driver who was identified by his Massachusetts DL #836477004. The investigation was then turned over to DS Pointu.

Was stopped by D/S O'Neal (#6408) for speeding and driving erratically (see supp PC). I was present as a backup. Upon approach to the vehicle, the driver was the only occupant. Driver was identified by his Massachusetts driver's license.

Glassy and bloodshot eyes. Had trouble with fine motor skills. Appeared drowsy. When asked to exit his vehicle, driver started to open the door then stopped and waited. Started again and waited. Eventually I had to ask him a second time to exit the vehicle.

DRIVER'S STATEMENTS:

Said that he came from a party and had a few drinks.

ODORS:

Very strong smell of unknown alcohol coming from inside the vehicle that followed the driver and became stronger when he talked.




