On February 10, 2017, at approximately 1456 hours, Officers responded to Louis Vuitton, 150 Worth Avenue #107, in reference to a retail theft in progress. It was reported that a Louis Vuitton "Monogram Clunny" handbag valued at \$2010 was taken from the store without payment. General Manager (W/M) Greg Beletsky (DOB, 01/11/66) reported a Hispanic male wearing a blue long sleeve shirt and black pants, and a Hispanic female, wearing a red cap, black shirt and black pants entered the store and removed the above handbag from the shelf. The H/M and H/F then bypassed all points of sale, before leaving with the unpaid item. Beletsky stated he contacted 911 and followed the subjects to their parked 2014 black BMW SUV, bearing FL tag# HOAV, in the 300 block of South County Road. Beletsky made contact with both subjects, at which time the H/F stated "sorry" and handed him the unpaid handbag.

Shortly after, Officer Dunn arrived on scene, at which time a BOLO was issued to patrol units in the area, in reference to the BMW. Based on this information, the vehicle was located in the 400 block of Royal Palm Way, in heavy traffic, by Sgt. Dawson. Contact was made with the occupants who matched the description of the subjects observed by Beletsky.

The driver (H/M) Julio Cesar Rodriguez Aragon (DOB, 07/30/76), and passenger (H/F) Cosette Rodriguez Cabrera (DOB, 04/27/78) were positively identified by their Florida driver's licenses and detained. Beletsky was transported to the 400 block of Royal Palm Way, at which time he positively identified Rodriguez Aragon and Cabrera as the subjects who had taken the unpaid handbag from the store, and as the subjects who later surrendered it to him.

At approximately 0645 hours, Regional Loss Prevention Manager with Louis Vuitton, contacted me via phone, at which time he stated he has been attempting to identify the above subjects for approximately 2 years, in reference to high end retail theft.

Based on the above facts, probable cause exists for the arrest of Cosette Rodriguez Cabrera, for Grand Theft, pursuant to F.S.S. 812.014 (2)(c)(1), because he knowingly and intentionally deprived the victim of property with a value more than \$300.00.
