NARRATIVE:

I responded to Target, 500 North Congress Avenue, Town of Lake Park, Palm Beach County, Florida in reference to a shoplifting case. I met with Loss Prevention Officer/Complainant Matthew Hanna, W/M, DOB 04-24-1981 who advised me of the following.

Matthew said that he observed a white female later identified as Courtney Lynn Conlan, W/F, DOB 12-19-1985 enter the store with a large purse and quickly head towards the women's clothing section where she began to select multiple items. He said Courtney continued to remove clothing from hangers and place the items into the shopping cart. Matthew observed Courtney take Target reusable bags out of her cart and begin to stuff them with the merchandise she selected. He said Courtney continued to walk through the store towards the exit, stopping at the infant, cosmetics and home goods section on the way. He said while in each section Courtney continued to take merchandise off the shelf and place it into the Target bags. Matthew said Courtney then makes her way to the checkout area, passed all points of sale without making a payment for any items and without permission to take said items. Matthew stopped Courtney at her exit from the store and escorted her back to the loss prevention office. Matthew went through the items, and completed an itemized receipt with the items stolen. Courtney stole a total of \$453.57 in merchandise.

When I entered the loss prevention office, Courtney was sitting on a bench in the office and was wearing a gray fur vest over her outfit. While standing in the office Courtney apologized and asked to pay for the merchandise she stole. Matthew requested

Courtney take off the fur vest because that was also an item she stole from the business. Courtney was placed in handcuffs behind the back, checked for tightness in fit and double locked. Deputy Reardon conducted a pat down on Courtney and discovered no other contraband. I explained to Courtney that she is being charged with Grand Theft.

Based upon my investigation and the facts of the case, I find probable cause to charge Courtney Lynn Conlan, W/F, DOB 12-19-1985 with violation of F.S.S. 812.014(2c1) Grand Theft \$300-\$5,000. Courtney was transported to the Palm Beach County Sheriff's Office Main Jail and transferred to Jail Deputies without incident.
