On the above date and time Lt. Johnson #7928 and Capt. Baer #9075 were on routine patrol in an unmarked police vehicle in the area of 3rd Ave North and North Dixie Hwy, Lake Worth, FL, 33460.

At the intersection of 3rd Ave North and North Dixie Hwy a white female, later identified as Nicole Carmona, approached the passenger front door of the vehicle that the Capt and Lt were driving and opened the door in order to sit in the front seat. Lt. Johnson advised me that once Nicole opened the door she spontaneously uttered "Oh...". Lt. Johnson and Capt. Baer advised PBSO dispatch that they were at this location speaking with a suspicious person.

I responded to the above location to assist Lt. Johnson and Capt Baer. Upon arrival Lt. Johnson advised me of the incident that occurred. Lt. Johnson advised me that Nicole was in possession of 5 hypodermic needles, which are commonly used to inject heroin, 1 glass pipe, commonly used to smoke crack cocaine, and one medal spoon. Lt. Johnson advised me that Nicole voluntarily informed him that she had "needles" when asked if she had anything illegal in her possession. I conducted a records check, regarding Nicole, via NCIC/FCIC and PALMS.

As I was conducting the records check an unknown white female was walking with a known prostitute named Margret Denton. Lt. Johnson asked the two females to walk over to us. The unknown female identified herself as Crystal Mcgee. Lt. Johnson asked Margret and Crystal for consent to search them for any illegal substances. Margret and Crystal gave Lt. Johnson and I consent to search them. Crystal emptied her bag onto the sidewalk and Lt. Johnson and I discovered a hypodermic needle in her possession.

Due to the above findings Probable Cause exists for the defendent to be charged with Possession of Drug Paraphernalia FSS 893.147(1)(b).
