

<p>On the 19th day of July 20 17 at 7:01 <input type="checkbox"/> A.M <input checked="" type="checkbox"/> P.M (Specifically include facts constituting cause for arrest.)</p> <p>On 07.19.17 at approximately 1844 hours, D/S C. Haugh observed a white male David Carmer and white female Crystal Ricci in the alleyway just west of South Federal Highway at the 1000 Block in the City of Lake Worth. Both subjects were sitting in the alleyway and had all their belongings spread throughout the alleyway. To be noted, the alleyway in this area is utilized primarily for your vehicle traffic and it not supposed to be blocked per City Of Lake Worth Ordinance 19-84. D/S C. Haugh parked his unmarked vehicle just to the north of the location and walked on foot towards the subjects. As D/S C. Haugh was walking towards the subjects, Ms. Ricci looked back at him and realized he was walking towards them. Ms. Ricci then quickly turned away for D/S Haugh and then in a panicked manner began shoving something towards the front of her pants as if she was trying to conceal or retrieve an item from inside her pants. Due to her suspicious behavior, D/S Haugh ordered Ms. Ricci to show him her hands. Ms. Ricci did not immediately comply and it took her several moments before she eventually showed him her hands. D/S Haugh asked Ms. Ricci to take a seat, which she did on an old tire on the side of the alleyway. While waiting for a backup unit to arrive on scene, Ricci was fiddling with her hands a small type clutch purse and cigarette pack as if she was trying to get rid of something on the ground. At this point D/S Haugh acted as if he did not see her dropping something and just watched as she tried to conceal the item by her legs. Due to Ricci's suspicious behavior, D/S Haugh requested a female Deputy to the scene to conduct a search. I then arrived on scene and conducted a search of Ms. Ricci. While conducting the search, I located a used hypodermic needle in Ricci's pants hidden under the inside of her jeans on the left side of her body. D/S Haugh then located a small clear 1x1 bag filled with 3 green pills which were identified as Clonazepam 1 mg (confirmed via poison control), and a small amount of suspected marijuana on the ground where Ricci was sitting. It should be noted that there were no other items where she was sitting beside the narcotics. The suspected marijuana was later field test with positive results utilizing a Duquenois-Levine. Due to the above facts, I determined that probable cause exists for the arrest of Ms. Ricci for Poss. Of Schedule IV Substance as per F.S.S. 893.13(6)(A), Poss. of Marijuana, less than 20 grams as per F.S.S. 893.13(6)(B), Poss. of Paraphernalia as per F.S.S. 893.147(1B), and for Hindering Use Of Vehicular Right Of Way as per City of Lake Worth ordinance 19-84.</p> <p>Hater transported Ms. Ricci to the CJ without incident. This case has been cleared by arrest.</p>
