

On 11-09-2017, at 0043 hours, I responded to 356 S. Silver Palm RD in reference to a domestic disturbance. Boca Raton Police Department dispatch advised the caller, W/F Rebecca Watkins stated she was hit by her husband during an argument and needed BRPD to respond. Upon arrival, I made contact with Rebecca outside of the residence. Rebecca advised she has been having issues with her husband, W/M Curtis Watkins, and currently going through a divorce. Rebecca advised Curtis and his friend, Christopher Wickstrom, arrived back at the residence intoxicated. While in the kitchen Rebecca stated she was grabbed and pushed by her husband. Rebecca advised she was able to record the incident and advised she will email the video. While speaking with Rebecca about the incident with her husband, Rebecca advised she was additionally battered by her friend W/F Amanda Kerwin. Rebecca advised Kerwin shoved her because she wanted Kerwin to leave the residence. As I was speaking with Rebecca about the issues at hand, Kerwin began antagonizing the situation by making comments (name calling) at Rebecca. At this time, Officer Burnette arrived and I had her stand by with Kerwin while I continued my investigation. It should be noted, Kerwin was highly intoxicated and irate during my interaction. I spoke with Wickstrom about the two separate incidents (in the driveway of the residence). Wickstrom stated he arrived back at the residence from a poker run with Curtis. He saw Rebecca and Kerwin arguing inside the residence. Wickstrom advised he did not want to be a part of the incident and went to sleep on the couch. Wickstrom advised he did not see any party get physical tonight. While interviewing Wickstrom, I observed Kerwin walking away from Officer Burnette. I then yelled to Officer Burnette that Kerwin was not free to leave since I was still


conducting an investigation and she was a suspect to an alleged battery. A few moments later, I observed Officer Burnette run after Kerwin. I then left Wickstrom and ran to assist Officer Burnette who was attempting to place Kerwin into custody. Kerwin continued to flail both of her arms and take evasive action away by pulling away from Officer Burnette and I. Once I made contact with Officer Burnette and Kerwin she continued to resist arrest. I advised Kerwin that she was under arrest. Officer Burnette placed Kerwin against Officer Calhoun's marked vehicle #339 (rear of the vehicle). It should be noted Calhoun's vehicle was parked in front of 330 S. Silver Palm Rd. Officer Burnette and I attempted to grab her arms but she kept flailing her arms to avoid being placed under arrest. Officer Burnette and I repeatedly told her to stop resisting. Once I grabbed a hold of her right arm she began to pull away. After analyzing the situation at hand and to avoid any officers from being injured by Kerwin's attempt to resist arrest, I decided to take her to the ground. I grabbed Kerwin's left arm with my left hand, used my right hand on her back and used my right leg to conduct a leg sweep to place her on the ground. Once she was on the ground, Officer Burnette and I attempted to place her into handcuffs. She continued to resist by pulling her arms away from her back. After a few moments she was subsequently placed into handcuffs after Officer Burnette and I were able to remove her arms away from her body. She was then placed into Officer Burnette's vehicle.

I spoke with Curtis about the issue at hand. Curtis acknowledged that he has been having issues with his wife and currently in the process of getting a divorce. Curtis advised he arrived back at the residence with his friends and saw Rebecca and Kerwin having an argument. Curtis advised he was never physical with his wife and that they were just arguing. It should be noted during my interaction, Curtis appeared to be intoxicated and had slurred speech and a strong odor of alcohol emanating from his breath.

I then spoke with Rebecca because she advised she has video footage for the alleged battery from her husband. Rebecca was able to show me the recorded video on her phone. The video shows all parties having an argument. In the video Curtis approaches Rebecca and it appears that Curtis grabs her because the phone is shaking while in her hand. This correlates to Rebecca's allegations. Officer Saavedra was able to obtain a copy of the video footage and witness statements. All evidence was submitted into evidence.

Subsequently after my investigation and reviewing all evidence, I placed Curtis Watkins under arrest. Curtis was placed into handcuffs and escorted into my marked patrol vehicle. He is being charged with simple battery (domestic) under Florida State Statute 784.03(1A1). A victim notification form was completed. Curtis Watkins was taken Palm Beach County Jail along with the rest of the arrest paperwork.

Additionally Amanda Kerwin was charged with resisting arrest without violence under Florida State Statute 843.02. Amanda Kerwin was taken Palm Beach County Jail along with


