<p>In the Town Of Ocean Ridge, FL, The following incident happened;</p> <p>Ofc. Parkerson conducted a traffic stop on a dark in color vehicle.</p> <p>I respond to the scene as a backup officer.</p> <p>I then approached the vehicle on the right passenger side front window. I noticed a strong odor emitting from the passenger side of the vehicle. Based on my training and experience this odor was consistent with the smell of Marijuana.</p> <p>The passenger was identified by her FL DL as Damaris Esther De Jesus. When I asked about the odor of Marijuana, De Jesus handed me a multi-color pipe. I then asked if there was any Marijuana in the vehicle and De Jesus handed me a clear zip lock bag containing a large amount of Marijuana.</p> <p>I asked De Jesus to exit the vehicle; I then read her Miranda Warnings. Post Miranda, I advised her that I was going to weigh the marijuana and she stated that she had a scale in her black bag located inside the vehicle on the front passenger floorboard. She was asked why she was in possession of such a large amount of marijuana which she stated, "I sell it."</p> <p>The suspected Marijuana was field tested and showed a positive color reaction to the presence of THC, the main ingredient in Marijuana.</p> <p>De Jesus was placed under arrest for Possession Of Marijuana with Intent to Sell and Possession of Drug Paraphernalia.</p> <p>De Jesus was transported to Ocean Ridge Headquarters for processing and later transported to Palm Beach County Jail.</p>
