

<p>On 07/17/2017 at approximately 2117 hours I was dispatched to 336 Golfview Rd #1218, North Palm Beach, FL in reference to a domestic dispute between husband/victim JAMES ANDREW JOHNSON (W/M 08/13/1961) and wife DANA CAROL JOHNSON (W/F 04/14/1965). Upon my arrival I met with James Johnson who stated to me that he and his wife had been drinking all day and had just returned home when his wife Dana Johnson became agitated over unknown circumstances and began to strike him. I observed a laceration to his left bicep which appeared to have been inflicted by nails. He also suffered a small laceration to the left temple and a scrape to his right knee. James Johnson stated that Dana Johnson, when drinking, has a tendency to become unmanageable and at times violent towards him.</p> <p>Dana Johnson stated that James Johnson was choking her on the carpet in the living room however she did not have any marks or abrasions and then stated that she attacked him in retaliation. Dana Johnson had an unknown alcoholic beverage emanating from her breath and body. She was unstable on her feet.</p> <p>Based on my investigation I find probable cause exists for the arrest of Dana Johnson for Simple Battery contrary to F.S.S. 784.03(1)(A)(2) because Dana Johnson actually and intentionally touched or struck another person against the will of the other causing bodily harm to another person.</p> <p>Dana Johnson was then placed in handcuffs which were double locked and checked for spacing. James Johnson refused to make a written statement.</p> <p>James Johnson completed a domestic violence risk assessment packet and based on the answers provided I contacted a risk assessment advocate.</p> <p>Dana Johnson was transported to North Palm Beach Police Department with her belongings while the proper paperwork was completed. Dana Johnson was wearing blue denim shorts and</p>


