PROBABLE CAUSE

On 8/11/2017 at approximately 10:22PM I responded to the scene of a vehicle crash at Donald Ross Road and Interstate 95. Upon my arrival I observed a silver Chevy Cavalier (FL tag: 422PEC) with severe damage to the front facing north in the intersection of Donald Ross Road and the Interstate 95 northbound exit ramp. I also observed a black Infiniti coupe (FL tag: DSVV42) with damage to the left front side facing northwest in the intersection near the silver Chevy Cavalier. I also observed an FDOT Interstate 95 sign that was knocked down and laying in the intersection that had been posted in the grassy median of Donald Ross Road. I spoke to the drivers of both vehicles and identified the driver of the silver Chevy Cavalier as Danette Gail Kolinski by her Florida drivers license (FL DL: K452167665410). As I spoke to Mrs. Kolinski I smelled the strong odor of an alcoholic beverage coming from her breath as she spoke. Her speech was also slurred and her eyes appeared red and glassy. After completion of my crash investigation I informed Mrs. Kolinski and notified her that I was beginning a criminal investigation for DUI. I read Mrs. Kolinski her Miranda Rights from my department issued card. She stated that she understood her rights and refused to answer any questions about what had occurred prior to the collision. As I spoke to Mrs. Kolinski I continued to smell the strong odor of an alcoholic beverage coming from her breath. I also continued to notice that her eyes were red and glassy and her speech continued to be slurred. I asked her to perform Standardized Field Sobriety Exercises (SFSEs) which she agreed to perform. I asked her if she had any medical conditions and she stated that she had Hyperthyroidism. She stated that she occasionally wore glasses but did not wear contacts and that her natural eye color was brown which was observed. The roadside exercises were performed in the two left turn lanes of westbound Donald Ross Road which were blocked off due to the vehicle collision. I asked her if she agreed that the surface upon which the exercises were performed was flat and free of obstructions and she replied yes. The results of those exercises are summarized below.

Horizontal Gaze Nystagmus

- Had jerky, unsmooth tracking of stimulus in both eyes
- Had horizontal gaze nystagmus at maximum deviation in both eyes
- Had horizontal gaze nystagmus prior to 45 degrees in both eyes

Walk and Turn Exercise

- Did not stay in the starting position as instructed
- Started exercise prior to my verbal command to begin
- On nearly every step she did not walk heel to toe, with her toe resting against the side of her heel.
- Did not turn around as instructed, pivoting both feet to turn around at the 9th step

One Leg Stand

- Placed foot down on the count of 8
- After placing her foot down she began counting from 1 again instead of continuing from the last number as instructed
- Placed her foot down on the count of 12

After completion of the SFSEs I determined that there was probable cause to believe that Mrs. Kolinski had committed the offense of driving under the influence of alcohol or a chemical or controlled substance. I placed Mrs. Kolinski under arrest at approximately 11:09PM for DUI. After being searched Mrs. Kolinski was placed in the backseat of my marked patrol vehicle and transported her to the Palm Beach County Breath Alcohol Testing facility. After a 20 minute observation period I asked Mrs. Kolinski to provide a breath test sample to test for the alcoholic content of her breath. She refused to provide the breath test sample after being read the Implied Consent warning. She was then read her Constitutional Rights and asked whether she was willing to answer any questions. She refused. She was subsequently taken to the central booking area without incident. All events occurred in Palm Beach County, FL.
