On the **21** day of **May**, **2017** at **19:26** (Specifically include facts constituting cause for arrest.)

The following incident occurred in the City of Delray Beach, Palm Beach County, Florida.

On 05/21/17, while Officer Batista was working an off duty detail at Sandbar 64 S. Ocean Blvd., the manager, Thomas Graham him to stand by while an intoxicated and unruly customer closed out his bill. Thomas had asked the subject to leave upon Officer Batista's arrival. While waiting for the waitress to bring the bill, the subject later identified as Daniel Brennan, became very aggressive with his girlfriend, who was also intoxicated. When Officer Batista asked Brennan to step away from his girlfriend, he said "fuck you, you cannot make me do anything." At this point Officer Batista grabbed his left arm and began to escort him towards the rear exit. Brennan slapped Officer Batista's arm which caused him to let go of his left arm. He again stepped towards his girlfriend's direction, so Officer Batista used an arm bar takedown (left arm) to escort him to the ground. Officer Batista advised him that he was under arrest and to not resist him. While Brennan was on the ground he grabbed both of Officer Batista's ankles and attempted to take him down. With the assistance of security Officer Batista was able to get handcuffs on one of his wrist, but he kept resisting arrest. He then tucked his free arm underneath his body preventing me from placing him in handcuffs. Officer Batista used a closed fist and struck him in the ribs as a pain compliance. The strike was effective and Officer Batista was able to place handcuffs on the free arm.

Based upon the above stated facts Probable Cause to charge Brennan with one count of Disorderly Intoxication, pursuant to F.S.S 856.011. As well as one count of Resist Arrest W/O Violence, pursuant to F.S.S 843.02.
