I advised him no, he was to recite the alphabet is a very mono tone, slow manner and I then demonstrated the proper way to perform this task. He then asked me the same questions again and I told him no again, I told him recite the ending of the alphabet as follows, "W, X, Y, Z". He advised he now understands the instructions and he then began to recite the alphabet. He recited it as follows, "A B C D E F G H I J K L M N O P Q S T U V U H Y AND Z".</b></p> <p><b>I then moved to the modified romberg balance task. He was asked to stand with his heels and toes together with his arms at his side. He would sway in a side to side back to front manner while standing here. I then gave him the following instructions, when I tell you to begin I want you to close your eyes, tilt your head back, estimate the passage of thirty seconds, when he feels thirty seconds has elapsed he needs to open his eyes, tilt his head forward and say the phrase "stop". I advised he he understood and he advised he did, I then asked if he knew the meaning of the words, estimate and elapsed and he advised yes. I then gave him the command to close his eyes and tilt his head all the way back and he did, I the gave him the command to start estimating and that is when I started timing him. When he tilted his head forward I asked him how many seconds that was and he advised 28, I then advised him that he was timed for 23 seconds. Estimating lower then that of 30 seconds is an indicator of a slowed internal clock which is an indicator of alcohol and or controlled substance useage.</b></p> <p><b>Based on the totality of the circumstances Dorrian was placed under arrest for operating a motor vehicle while under the influence of alcohol and or a controlled substance. He was placed in PBSO issued handcuffs which were checked for proper fit and double locked. He was then seat belted in the rear of my patrol vehicle and transported to the Palm Beach County Sheriff's office breath alcohol testing facility located at the main detention center. After arrival at the BAT facility he was observed for a period of twenty minutes during which time he did not take anything by mouth or regurgitate. He was then brought into breath testing room B where I requested a sample of his breath for the purpose of determining it alcohol content, after agreeing to do so he sat in the chair and then began to ask what will happen if he doesn't provide a breath sample, I then explained Florida's implied consent law and after he advised he understood he agreed to provide a breath sample. He provided two samples the first of which was a .164 and the second of which was a .153. He was booked into the Palm Beach County Jail without incident.</b></p>

## PERSONAL CONTACT

### DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 6/13/2017 at approximately 0256 hours I was conducting vehicle patrol in the area of Okeechobee Blvd and Interstate 95, West Palm Beach, FL, 33417 in unincorporated Palm Beach County. I was driving my marked patrol vehicle asset number 68559 and wearing my Palm Beach County Sheriff's office issued class B uniform. While traveling eastbound on Okeechobee Blvd approaching Interstate 95 I noticed a white in color Nissan SUV bearing Florida license plate number GCN-U39 traveling eastbound in the number 2 lane. I was in the number 1 lane and about a car length behind this vehicle watching as it was driving down the roadway. I noticed that the vehicle would drift slightly to the right side of the travel lane, sometimes driving over the white then then jerking the wheel back into the travel lane. At this time I activated my dash camera to capture this driving pattern. As I was following this vehicle I ran the license plate and that is when I got information back that this vehicle's registration was expired more then six months. I continued to follow the vehicle as it was traveling eastbound and as I was following the vehicle it continued to drift onto the right line of the travel lane and then jerk back into the center of the travel lane, this is a common activity that a driver may perform when he or she is under the influence of alcohol and or a controlled substance. It was at this time, based on the current driving pattern and the fact that the vehicles registration was expired that I decided to conduct a traffic stop. I activated my emergency lights and siren to signal the vehicle to pull over. The vehicle complied and pulled off to the right should of Okeechobee Blvd just east of Interstate 95. The vehicle came to a final stop half way in the bike lane and half way in the number 4 lane of travel.

### OBSERVATION OF DRIVER:

I then exited my patrol vehicle and approached the suspect vehicle on the drivers side, as I was approaching the vehicle I noticed the driver rolled the driver side window down. As I reached the passenger rear window I could smell the slight odor of an unknown alcoholic beverage emitting from the open window of the vehicle. When I reached the drivers window I noticed there was a white male, wearing a blue long sleeve shirt, tan pants and blue shoes sitting behind the driver wheel, in actual physical control of the motor vehicle. At the time of my traffic stop no other passengers were located inside the vehicle. Immediately upon making contact with the driver I could smell the strong odor of an unknown alcoholic beverage emitting from inside the vehicle and on the drivers person, his eyes were blood shot and watery, his speech was slow, thick and slurred. His shirt appeared to be wrinkled and slightly un-tucked. I introduced myself and asked the driver for his driver's license, vehicle registration and proof of vehicle insurance. I then explained to the driver that the reason why I was speaking with him is because his vehicles registration was expired more then six months, and I also explained that I was following him for quite some time and he appeared to be swaying into other travel lane. He then advised me that the reason why his registration was expired is because he lives in New York and his vehicle stays down here. I then asked him again for his vehicle documents because when he started explaining why his vehicles registration was expired he stopped looking for the documents I requested. After I asked him again for his documents he reached into his wallet which was located on his lap and started looking through his wallet, he appeared to be having difficulty locating his drivers license. He then produced a New York State drivers license identifying him as Daniel Dorrian. The photo on Dorrian's drivers license appeared to be that of a very young man, possibly in his early twenties, when I asked him when he was issued this drivers license he advised not too long ago.

### DRIVER'S STATEMENTS:

I then asked him dont they update the drivers license photos as you get older or as you get new driver's licenses issued and he advised "no he will get a new photo in 2025". I found this odd due to the fact that Dorrian was approximately 40 years of age and did not look anything like the person in the photo ID. I ran a records check and communications advised the registered owner of the vehicle was that of Daniel Dorrian and she advised he had a valid drivers license out of the state of New York with no Florida DL or criminal past in FL. I then went back to my vehicle and based on the way Dorrian was driving and the cues of impairment I noticed when I first spoke with him I made the decision to conduct a criminal DUI investigation, I backed my patrol vehicle up to make room. I chose a smooth level portion of the as fault roadway, free of obstructions and debris in order to perform roadside tasks. I also used a white line painted by the Florida department of transportation in order to perform the walk and turn task. I then re approached Dorrian and asked him to step put of the vehicle, I brought him behind his vehicle and explained to him that I could see several signs of impairment on him and at this point I would be conducting a criminal DUI investigation.

### ODORS:

I asked him if he understood and he seemed confused, I then explained that I would run him through standardized roadside tasks and based on his performance we would go from there. He agreed to do so so I then asked him the following questions, do you have any medical problems, and he advised no, I then asked if he had any conditions which would cause his breath to emit the odor of an unknown alcoholic

## Other Observations:

Beverage and he advised no, I asked him if he had a speech impediment and he advised no, I asked him if he had any problems with his eyes or did he wear prescription glasses or contacts and he advised no. Throughout this process of questioning I could smell the strong odor of an unknown alcoholic beverage emitting from his breath, this odor intensified as he spoke with me. I then asked him to stand with his heels and toes together with his arms at his sides, I demonstrated how to stand then moved to the correct instructional stance.

## WALK &amp; TURN:

While standing in this position he would sway in a side to side back to front manner. I then placed a lighted stylus pen approximately 12 inches away from his face just above to eye brow line, I asked him if he could identify the color of the light at the end of the pen and he advised "red" which was correct. I then gave him the following instructions, When I say go I want you to touch the tip of the red light with your right index finger and then bring your hand back to your side. I demonstrated how to perform this task and then asked if he understood and he advised he did. I then gave him the command to go and he brought his right index finger up to the light and lowered his right index finger onto the red light. I then moved to the lighted pen task. He was asked to stand with his heels and toes together with his arms at his side and remain in this position, while standing here he would sway in a side to side back to front manner. During the horizontal gaze Nystagmus (HGN) task the drivers eyes displayed equal pupil size and equal tracking. The driver's eyes displayed lack of smooth pursuit, distinct and sustained Nystagmus at maximum deviation and distinct and sustained Nystagmus prior to 45 degrees. During the Vertical gaze Nystagmus (VGN) task the drivers eyes displayed equal pupil size and equal tracking. The driver's eyes displayed lack of smooth pursuit, distinct Nystagmus when looking all the way up / all the way down. The driver's eyes also displayed onset of Nystagmus prior to 45 degrees when looking all the way up / all the way I then moved to the Walk and turn task, Dorrian was asked to place his left foot on the white DOT line and then placed his right foot directly in front of it in the heel to toes position with his arms down at his sides, I stood next to Dorrian and demonstrated the proper way to stand in

## ONE LEG STAND:

This instructional stance. He first bright his right foot to the front of his left foot however they were not heel to toe. The heel of his right foot was touching the tow of his left foot only on the far right side of his right heel, he was not in the heel to toe position so I showed him how I was standing and I asked him to stand like I was and he then moved to the heel and toe position. I told him to stand here and do not move while I explain this task. I noticed that Dorrian was visibly shaking, he at one point made the statement that he was nervous, He would also sway roughly in a side to side back to front manner. After explaining this task Dorrian advised that he understood and that is when I gave him the command to begin. On the first round he missed steps one through nine, he stubled and he was not in the demonstrated heel to toes position. When he reached the turn he asked me which way he should turn and I told him to turn like I demonstrated, He then performed the turn other that the way I just showed him. On the second set of heel to toe steps he missed steps one through nine by not walking in the demonstrated heel to toe position and stumbling a few times while walking. I then moved to the One Leg stand task. He was asked to stand with his heels and toes together with his arms down at his sides, While standing in this position he would sway roughly in a side to side back to front manner.

## FINGER TO NOSE:

I then gave him the standard instructions for the One leg stand task and he advised he understood. I then told him to begin and he raised his right foot however it was not the approximated six inches like I showed him, he would also sway roughly and lean over slightly as if he was starting to fall however he would catch him felt and bring his body back upright. While counting in the demonstrated one thousand one one thousand two manner I noticed several errors, He counted as follows 1001, 1002, 1003, 1004, 1005, 1006, 1007, 1008, 1009, 1010, 1010, 1017, 1018, 1018, 1020, 1022, 1024. He would also mumble while reciting this counting sequence so some of what he said was hard to hear however he was unable to properly count in order and I would later learn during the second to last task that Dorrian is college graduate. I then moved to the Finger to nose task. He was asked to stand with his heels and toes together with his arms at his sides, he was then asked to raise his hand parallel to the ground, mark a fist with both hands, point both his index fingers, turn both hands toward the sky, and then bring both hands back down to his sides. I walked Dorrian through this movement with him at the same time that I was giving commands.

## ROMBERG ALPHABET:

He was then giving the standardized instructions for this task after which he advised he understood them. At this time I asked him to tilt his head all the way back, close his eyes, He was then given the following sequence for this task. L R L R R L. When giving each command he would bring the mentioned index finger up to his nose however he would touch just above the nose, which was other then the way I demonstrated. He would also sway roughly in a side to side back to front manner. I then moved to the Romberh Alphabet task. Dorrian was asked to stand with his heels and toes together with his arms at his sides, Whiles standing here he would sway in a side to side back to front manner. I then asked him what his highest level of education was and if he knew the English alphabet, he advised college graduate and he knew the English alphabet. I then gave him the standardized instructions for this task. He then asked me
