On February 12, 2018 at approximately 0246 hours while on patrol in the City of West Palm Beach, Florida, I responded to 2905 45th Street (Rachel's Gentleman's Club) in reference to a trespassing.

Upon arrival, officers made contact with Manger Arthur Jones (W/M 07/13/1979) who advised he had a customer, later identified as Daniel Gardner Russillo (W/M 11/08/1977), who was refusing to leave the property and the business was now closed.

I made contact with Russillo and advised him that he needed to leave the property per management of the business. After some time, Russillo began to walk to the middle of the parking lot and stopped. Russillo was then warned again several times to leave the property or he shall be arrested for trespass. Russillo was afforded several chances to call for a taxi, Uber, family member, or a friend to be picked up and taken home. Russillo again refused any attempt or effort to leave the property after warning. Russillo then became highly belligerent and vulgar towards officers and stated "Fuck you! I'm not leaving!".

Due to the above facts, I find probable cause to arrest Daniel Gardner Russillo for Trespass After Warning - Property per F.S.S. 810.09 (2) (B).
