B.U.I. PROBABLE CAUSE AFFIDAVIT

PERSONAL CONTACT

DRIVING PATTERN:

BLACK CENTER CONSOLE VESSEL WITH 3 OCCUPANTS WAS SOUTHBOUND IN THE INTRACOSTAL WATER WAY AT MARKER 60 WITHIN THE VILLAGE OF TEQUESTA. THE VESSEL WAS TRAVELING AT AN EXCESSIVE SPEED. VESSEL SPEED WAS ESTIMATED AT 45 MPH. STATIONARY RADAR WAS UTILIZED AND A SPEED READING OF 46 MPH WAS OBSERVED ON THE DECATUR RADAR DEVICE (#05940). THE VESSEL WAS TRAVELING IN A POSTED 25 MPH MANATEE ZONE WITHIN THE VILLAGE OF TEQUESTA. THE VESSEL ALSO OVERRAN THE SLOW SAFETY ZONE 100 YARDS NORTH OF THE CR707 BRIDGE IN VIOLATION OF STATE LAW.

A TRAFFIC STOP WAS CONDUCTED ON THE VESSEL AND IT PULLED INTO THE JIB CLUB MARINA AT 46 SOUTH BEACH RD. WHILE ATTEMPTING TO DOCK THE OPERATOR (LATER IDENTIFIED AS DANIEL G HENDERSON, W/M, 11/14/92) MOVED THE BOAT ABRUPTLY AND ONE OF THE PASSENGERS FELL OUT OF THE BOAT.

OBSERVATION OF DRIVER:

UPON CONTACT WITH HENDERSON A STRONG ODOR OF AN UNKNOWN ALCOHOLIC BEVERAGE WAS DETECTED ON HIS BREATH. HIS SPEECH WAS HEAVILY SLURRED AND HE WAS ANSWERING IN ONE WORD ANSWERS, SOMETIMES NOT UNDERSTANDABLE OR TO THE CORRECT QUESTION. HIS EYES WERE GLASSY AND REDLINED. HE HAD DIFFICULTY FOLLOWING DIRECTIONS. ONCE OFF THE BOAT, HE WAS EXTREAMLY OFF BALANCE AND ATTEMPTED TO WALK AWAY SEVERAL TIMES. THE SUBJECT WAS VERBALLY ABUSIVE AND WOULD NOT FOLLOW DIRECTION.

DRIVER'S STATEMENTS:

HE STATED "I FINE". WAS TALKING OUT LOUD TO NOBODY ABOUT HOW MUCH HIS FAMILY DOES FOR CANCER AND LYMPHOMA AND HOW MUCH HIS FAMILY GIVES TO THE POLICE. STATED "YOUR SO FIRED"

STRONG ODOR OF UNKNOWN ALCOHOLIC BEVERAGE

SPEECH: HEAVILY SLURRED, ONE WORD ANSWERS THAT DID NOT MATCH QUESTIONS

ATTITUDE: VERBALLY RESISTANT AND HOSTILE AT TIMES SWITCHING BACK AND FORTH TO COOPERATIVE

CLOTHING: SHORTS, NO SHOES, TOOK OFF SHIRT WHILE WAITING TO DO ROAD SIDE EVALUATION




