The undersigned certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following violation of law. The Person taken into custody... [] committed the below acts in my presence. [] confessed to... [] was observed by DORMAL ALLEN who told OEC. MCCRAY II that he/she saw the arrested person commit the below acts. [] was found to have committed the below acts, resulting from my (described) investigation. On the 31 day of May, 2018 at 00:33 (Specifically include facts constituting cause for arrest.)

On Thursday, May 31, 2018 at approximately 12:33 a.m. I, Officer McCray II was dispatched to Dirty Martini located at 11701 Lake Victoria Gardens Avenue in Palm Beach Gardens, in Palm Beach County Florida; in reference to a disorderly male later identified through his Florida driver's license as Daniel Kennedy (W/M DOB: 11/19/1995). My body-worn camera was activated for the duration of this investigation.

Dirty Martini's Manager later identified as Dormal Allen (W/M DOB:10/18/1990) advised me that Kennedy refused to leave property after being asked by numerous security officers and employees working for Dirty Martini. Allen observed Kennedy approaching multiple servers speaking racial slurs and yelling at other guests. While exiting through the front door of Dirty Martini, Kennedy began screaming obscenities and racial slurs at guests and employees of Dirty Martini. Allen advised that Kennedy called him a "nigger", and the female servers "bitches".

I observed Kennedy to be very irate upon making contact with him. Officer Hennessey then asked Kennedy to produce his Florida driver's license, but he stated he did not have it with him. Officer Hennessey then observed Kennedy's Florida driver's license behind another card in his wallet, and Kennedy reluctantly gave it to him. While Officer Hennessey relayed Kennedy's information to dispatch, Kennedy became more upset. Kennedy stated, "you guys have no right to look at my driver's license." in an aggressive manor while yelling obscenities and racial slurs which breached the peace of guests, and employees of Dirty Martini.

Based upon my investigation, I find probable cause to arrest Kennedy with (1) count of disorderly conduct, pursuant with Florida State Statute 877.03. Kennedy was transported


