D.U.I. PROBABLE CAUSE AFFIDAVIT

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 03/26/19 at approximately 0345 hours, Ofc. Abraira #402 observed a black Audi sedan bearing FL Tag (BQQQ57) travel North on I-95 approaching Donald Ross Rd. Ofc. Abraira observed the vehicle failing to maintain a single lane, drifting from the middle lane to the far right lane. The vehicle then exited the interstate and traveled East on Donald Ross Rd. The vehicle continued to drift over the boundary lines of the middle and outside lanes, eventually striking several cones on the outside shoulder of the roadway. Ofc. Abraira ignited his overhead lights at the intersection of Donald Ross Rd, and the vehicle immediately applied its brakes and coasted at approximately 10-15mph to approximately 150 feet East of the intersection of Donald Ross Rd/N Military Trl. Ofc. Abaira approached the vehicle and observed a white male sitting in the driver's seat who was identified as Daniel Sexton via his FL DL.

OBSERVATION OF DRIVER:

Upon approach to the vehicle I observed Sexton sitting in the driver's seat. I observed his pupils to be dilated more than a normal persons, the sclera of his eyes to be reddened, his eyes to be watery, his face to be flushed, and his speech to be slow and mumbled. I requested he exit the vehicle at which point he used the door for support while walking away from the vehicle and had an ataxic gait. Sexton had an orbital sway while standing with his feet shoulder width apart.

DRIVER'S STATEMENTS:

Sexton stated he was coming from West Palm Beach to Jupiter to drop a friend off at his residence. I asked where in Jupiter and he then stated he was going to Juno Beach. I questioned Sexton about the several traffic cones he struck near I-95 and he stated he did not see them and does not remember it. Sexton stated he consumed 2-3 glasses of wine at about 2-3 hours ago. He stated he consumed them around 3am, however when asked what time it was he stated it was 3am, when the actual time was 4am.

ODORS:

Strong odor of alcohol emitting from his breath from a conversational distance.

GENERAL OBSERVATIONS

SPEECH: Slow, mumbled

ATTITUDE: Polite

CLOTHING: Clean

MEDICAL/OTHER: Sexton stated he did not consume any medications and did not have any ailments that would preclude him from being able to operate a vehicle or perform daily tasks.

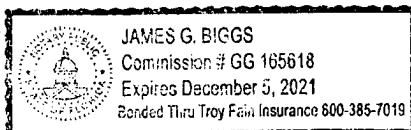

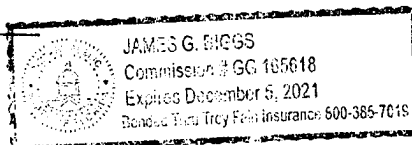
