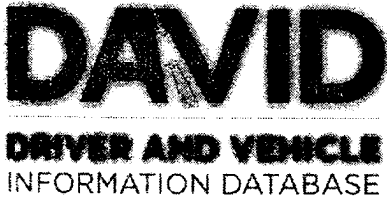

## PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

ON THE ABOVE DATE AND TIME WHILE ON ROUTINE PATROL OF THE ICW AT THE JUPITER INLET D/S MILLER 6347 AND I NOTICED A WHI BAYLINER VESSEL HEADING EAST OF THE OF THE JUPITER INLET. THE VESSEL WAS IN A SLOW ZONE AND THROTTLED THE VESSEL BRINGING THE VESSEL ON PLAIN. THE VESSEL THEN REDUCED HIS SPEED WHEN THEY NOTICED OUR MARKED PATROL VESSEL. WE CONDUCTED A BOAT STOP ON THE VESSEL WITH HULL # FL1573LE.

### OBSERVATION OF DRIVER:

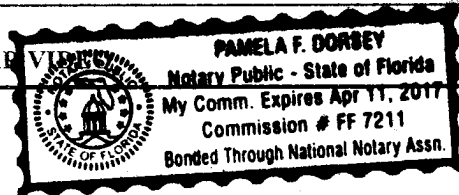

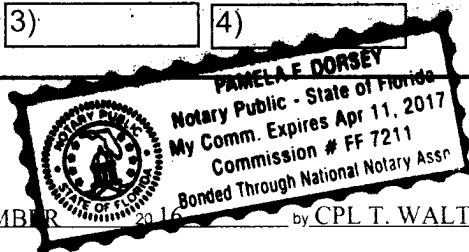
