According to Helton, she came to the house to pick up a pair of shoes and talk to her ex-boyfriend, Daniel Buddie, who was staying at his friend's house. Helton, who lives in Orlando, was home for the holiday break. Helton stated when she arrived Buddie came out to her car to give her the shoes and then sat down inside the car to speak with her. At some point, the discussion became hostile, and Buddie became angry. Helton claimed Buddie grabbed the door handle with his right hand, and then swung at Helton, hitting her on her chest, with his left hand. Buddie then exited the car and went into the house. Helton attempted to follow him but was stopped by the occupants of the house. Helton then returned to her car and called police. Helton pulled down the top of her sweater and showed me her sternum, which had a slight reddish mark approximately 6 inches in diameter. Helton stated she took pictures of the red mark with her cell phone. Helton declined medical attention. Helton stated her and Buddie were in an exclusive dating relationship for approximately 3 years, starting sometime in 2015, and had broken up a few times throughout the relationship, most recently 3-4 months ago. Helton advised she and Buddie were last intimate approximately 3 weeks ago, before Buddie went to Texas for work. Helton completed a written statement which was placed in to BRPD evidence and was provided with a Domestic and Dating Violence Notice of Legal Rights and Remedies pamphlet. It should be noted, after speaking with all parties involved, the red mark on Helton's chest was no longer visible and was therefore not photographed.

I then met with Daniel Buddie who had been waiting inside the house. According to Buddie, he and Helton had dated for 3 years and broke up 4 months ago. Buddie stated he was still in love with Helton and wanted to get back together with her. Buddie, who lives in Orlando, advised he came down to Boca to stay at his friend Joshua White's house. Helton came to the house to pick up a pair of shoes and speak to Buddie. Upon Helton's arrival, Buddie went out to her car, got inside, and gave her the shoes. The two then began talking about their relationship when the discussion escalated into an argument. Buddie advised he did not want to argue with Helton, so he got out of the car and went inside until police arrived on scene. When asked about the red mark on Helton's chest, Buddie stated he did not hit her. Buddie claimed at no time did he touch Helton. Buddie completed a written statement which was submitted to BRPD evidence.

I then spoke with Joshua White Sr. who owns the house. White stated Buddie has known his family for a few years and was staying with them for a few days and advised he has never met Helton before. White advised he and his family were inside the house when the incident occurred and stated they did not witness any of the event. White stated he no longer wanted Helton on his property. Helton was issued a trespass warning for the property by White in my presence. Helton indicated she understood.

Based on the information obtained during my investigation and the red mark on Helton's chest observed upon my arrival, I placed Daniel Buddie under arrest for Domestic/Dating Battery in violation of F.S.S. 784.03(1). Buddie was transported to BRPD for booking and then turned over to Palm Beach County Jail.
