


Marth went upstairs to ascertain what was happening and he observed a male, later identified as Daniel Warner, standing in the hallway in front of apartment [REDACTED]. Marth told me that Daniel stated his [REDACTED] pulled the fire alarm and would not allow him back into his residence. Marth then went back to his apartment. Marth did advise to me on sworn video statement that the fire alarm did in fact disturb his evening at home, causing him to evacuate.</p>






I was approached by a male, later identified as Keith Marth, who advised he heard two males arguing above his first-floor apartment about a credit card. Marth went upstairs to ascertain what was happening and he observed a male, later identified as Daniel Warner, standing in the hallway in front of apartment [REDACTED].
