ON THE ABOVE DATE AND TIME I RESPONDED TO THE BOCA REGIONAL URGENT CARE LOCATED AT 20665 LYONS RD. #A3 IN UNIC BOCA RATON IN REFERENCE TO A DISTURBANCE IN PROGRESS. THE CALLER SAID A MALE CAME IN AND HIT A WOMAN IN THE WAITING ROOM. IT APPEARED TO HAVE BEEN A MARRIED COUPLE. THE CALLER SAID THE MALE WAS STANDING BY A BLACK INFINITI AND THEN LEFT THE AREA. UPON ARRIVAL I MET WITH AN EMPLOYEE WHO WAS IDENTIFIED AS ASHTON FOX WHO COMPLETED A SWORN WRITTEN STATEMENT. SHE SAID A PATIENT CAME IN AND BROUGHT HIS FRIEND WITH HIM. AS THEY WERE SITTING A MALE WHO WAS LATER IDENTIFIED AS DANIEL ROSENBAUM APPROACHED THE MALE, IDENTIFIED AS JAMIE MANN, AND THE WOMAN, IDENTIFIED AS CHERYL ROSENBAUM, AND BEGAN TO YELL AT THEM. HE FIRST APPROACHED MR. MANN AND WHEN SHE SAID TO STOP, MR. ROSENBAUM JERKED HER OUT OF HER CHAIR AND WAS SHAKING HER AROUND WHILE HE WAS CUSSING. BOTH MR. AND MRS. ROSENBAUM WENT OUTSIDE AND THEY WERE YELLING AT EACH OTHER. MR. ROSENBAUM GOT IN HIS VEHICLE AND LEFT AS SHE CAME BACK IN. I SPOKE WITH MRS. ROSENBAUM WHO SAID HER HUSBAND CAME IN AND STARTED YELLING AT HER CALLING HER DEROGATORY WORDS. AT ONE POINT HE GRABBED HER BY BOTH ARMS AND STARTED TO HOLD HER AS HE YELLED. SHE SAID THAT AT ONE POINT HE WAS CLENCHING HIS FISTS AND APPEARED HE WAS GOING TO HIT HER.

I MADE CONTACT WITH MR. ROSENBAUM OVER THE PHONE AND ASKED HIM TO MEET AT THE PBSO DISTRICT 7 SUBSTATION IN WHICH HE AGREED. AT APPROX. 1230HRS I MADE CONTACT WITH MR. ROSENBAUM. HE WAS READ HIS CONSTITUTIONAL RIGHTS FROM A PBSO PREPARED CARD IN WHICH HE STATED HE UNDERSTOOD AND DECLINED TO SPEAK AND ASKED FOR HIS ATTORNEY. BASED ON THE STATEMENTS BY THE VICTIM AND THE WITNESS, DANIEL ROSENBAUM WAS ARRESTED AND CHARGED WITH DOMESTIC BATTERY PER F.S.S. 784.03(1A1).
