Rosemary Ave. in reference to a report of a disturbance between two females. I arrived on scene and met with PSC Ofc. Bedasie, who was in the company of Danielle Mammano. Mammano had been drinking at Copper Blues and Blue Martini. I spoke with Mammano in an attempt to acquire her cab services to leave the area and back to her residence.</p> <p>From the time I met with Mammano she was slurring her speech and was not forming coherent sentences due to apparent alcohol intoxication. While speaking with Mammano, she approached me and stood approximately 1 ft. away from me. At this point, I could see that Mammano was swaying while she was standing and had the pungent odor of alcohol emanating from her breath. Mammano continued to be verbally abusive towards me and initially complied with my request for her to back up and give me space. Mammano continued to be verbally abusive to me and speaking with a high tone of voice which caused several pedestrians in the area to redirect their attention to our interaction. I attempted to guide Mammano to the awaiting taxi cab to leave the area. At this juncture, Mammano raised her left hand and said "fuck you". Due to the close proximity of Mammano to my person, her agitated state, her apparent intoxication, and my perceived threat of physical violence to myself due to Mammano's raised hand I pushed Mammano away from me in an attempt to defend myself from physical violence. Mammano got up and approached me again; I instructed her once again to get in the cab and advised that jail would be her alternative if she kept up her behavior. Mammano then pushed my chest area with an open hand.</p> <p>At this time, Ofc. Lobdell and I attempted to arrest Mammano for Battery on a Law Enforcement Officer. Mammano was then placed on the ground to be handcuffed to prevent</p>

Mammano, she was able to get a hand free and open palm slap me on the upper right portion of my head. Mammano was finally able to be placed in handcuffs, which were double locked and checked for proper spacing. Mammano was placed in the back of my marked patrol vehicle where she continued her violent verbal and physical outbursts.

Based on the above stated facts I find probable cause to charge Mammano with (1) violation of FSS 856.011 disorderly intoxication due to the fact that Mammano exhibited signs of alcohol intoxication and caused a public disturbance, (1) violation of FSS 784.07(2B) Battery on Law Enforcement Officer due to the fact that Mammano intentionally struck me with her open hand, and (1) violation of FSS 843.01 Resisting officer with violence due to the fact that I was in the lawful execution of my duties (attempting to arrest Mammano) when she intentionally and willfully struck me on the head with an open hand.
