In the City of Riviera Beach, Palm Beach County, Florida, the following incident occurred:

On June 21, 2018 at approximately 12:31 a.m., officer were dispatched to 2304 North Congress (Abbey Apartment Complex) in reference to a Disturbance. Upon my arrival, Officer Westcarth made contact with Natalie F Fleming (W/F 9/26/95). I observed Fleming crying with tears running down her face and red bruise under her left eye.

Fleming provided a recording statement:

Fleming stated at approximately 12:00 A.M., that Danielle Mowday (W/F 9/18/95) texted her to meet up to talk. Fleming did not reply back because she did not want to have any discussion with Mowday. Mowday called her brother Dylan Mowday (W/M 11/20/93) which is Fleming boyfriend. Mowday was telling Dylan that she going to smash Fleming face in when she sees her. Dylan told Fleming let's have a discussion with his sister Mowday to find out why she's upset with you.

Fleming told me that she and Dylan agreed to meet Mowday in front of the apartment complex outside of the gated area. Dylan drove his vehicle with Fleming sitting on the front passenger seat and park his vehicle outside the gated area. Mowday exited her vehicle and came up to Dylan window, and Dylan told to her let's talk. Mowday told them "No! That Fleming need to get out of the car like woman and talk."

Fleming stated that she got out of the vehicle to talk with Mowday. Mowday immediately began shouting and screaming at her. Fleming told Mowday to stopped shouting and screaming at her. Fleming stated that Mowday immediately got violent and punch Fleming in the face twice and started pulling her Fleming hair almost causing her to fall to the ground. Dylan was able to pull Mowday off Fleming so Fleming could get away from

Fleming and Dylan were able to get back into his vehicle to attempt to get away from Mowday. Fleming started calling the police, and Mowday heard Fleming on the phone with police and got upset. Mowday was able to run over to the passenger side door where Fleming was sitting, and opening up the door and punch Fleming twice in the face. Dylan once again pull Mowday away from Fleming. At the same time Mowday friend called to her to get into the car so they could leave the area.

Mowday was transported to Riviera Beach holding cell for processing.

During my investigation, Officer Westcarth gave Fleming a Victim's Right's Pamphlet and Fleming signed an Affidavit of Complaint. Photographs and a recorded statement from Fleming and Dylan was uploaded into Riviera Beach Arbitrator.

Danielle Mowday (W/F 9/18/95) was charged with one (1) count of Simple Battery 784.03 (1A1)

Mowday was later transported to Palm Beach County jail.
