Narrative:

I responded to 512 Bayfront Dr, Boynton Beach, FL, 33435 in reference to a domestic call.

BBPD Communications (Dispatch) advised the caller/victim later identified as W/M Christopher Castronova (DOB 7/27/73) stated that his child's mother W/F Danielle Simmons (DOB 1/27/88) was outside of his residence trying to break in, by forcing her way in. He advised she hit him and his cousin W/M Thomas Defazio (DOB 6/4/52).

Let it be known Christopher Castronova and Danielle Simmons were once married, lived together, and have a child in common.

Upon arrival I made contact with Simmons outside of the residence, her shirt was off and she was screaming that her child in common with the caller W/F/J Sophia Castronova (DOB 8/20/14) was in danger. Officers immediately went into the residence and made contact with the child who was not in danger, not injured and with her father. I obtained a sworn statement from Simmons which was recorded on my body worn camera. The following is a summary of my interview with Simmons which is not verbatim: Simmons stated she was at home when she got a subconscious feeling that her child was in danger. Because of this she got a ride to Christopher Castronova's residence to check on her child because of her subconscious feeling. Simmons advised she arrived at the residence and Defazio opened the front door partially. Simmons then heard Sophia screaming and crying so she attempted to enter the residence. At this point Defazio and Christopher were standing in front of the entrance. Simmons advised she stuck her foot into the residence and tried to go through Defazio and Christopher to get inside of the residence. Simmons stated at this point she got into a scuffle with the two parties because they were trying to push her out of the residence and she was trying to get inside. Simmons advised at some point she grabbed Defazio by the shirt and when asked advised she may have ripped Christopher's chain off during the fight. Simmons advised Christopher then pushed her out of the doorway and at one point grabbed her with both hands around her neck and choked her but that she never lost consciousness. She also advised she was able to breath during this time. Simmons stated Defazio then locked her out of the residence while Christopher held her back. Simmons also stated she received an injury to her right elbow at some point but does not know how she got it. Simmons additionally stated at some point during the altercation her shirt got ripped off but did not know exactly how. I observed no injuries or signs of redness on Simmons neck. I did observe a laceration on her right elbow. Photos of the injuries were taken. Simmons refused any medical treatment.

I then made contact with Christopher. I obtained a sworn statement from Christopher which was recorded on my body worn camera. The following is a summary of my interview with Christopher which is not verbatim: Christopher stated he was at his residence with his cousin Defazio and his daughter Sophia. He advised he was giving his daughter a bath when he heard a knock on the door. Defazio answered the door and yelled to him because it was Simmons. Christopher stated when he got to the front door Simmons was just inside the front door of the residence and was grabbing Defazio by his shirt collar and was punching him in the face. Because of this Christopher went to help Defazio and helped by pushing Simmons out of the residence. Christopher stated the entire time Simmons was punching, kicking, and pushing him. He stated that during the altercation Simmons pulled him by his shirt collar and ripped his chain off of his neck. She also scratched his left hand. Christopher stated he was able to push her outside of the residence where Defazio was then able to shut and lock the door to stop her. I observed the broken necklace around Christopher's neck and the pendants were also located outside the front door, which was consistent with his statement. I also observed a small red mark on his left hand. Christopher refused medical treatment, photos were taken.

Christopher stated Sophia was in the bathroom the entire time and did not witness the incident. He also advised she was not screaming and crying like Simmons advised.

Next I made contact with Defazio. I obtained a sworn statement from Defazio which was recorded on my body worn camera. The following is a summary of my interview with Defazio which is not verbatim: Defazio stated he heard a someone at the front door and answered the door. Defazio stated Simmons was at the front door which he advised her that she is not supposed to be there and told her to leave. Defazio stated Simmons then tried to force her way inside of the residence. While doing so she grabbed onto Defazio's shirt collar causing redness to his neck area. Defazio stated Simmons started punching him in the left side of his face while he was trying to stop her from entering. At this point Defazio called for Christopher's help. Christopher came and helped push Simmons out of the residence while he shut the door and locked her out. Defazio also stated he witnessed Simmons rip Christopher's necklace off his neck. I observed red marks around Defazio's left side of his neck consistent with his statement. I did not observe any injuries on his face. Defazio refused medical treatment, photos were taken.

Lastly I made contact with Sophia. I observed no injuries on Sophia and emotionally she seemed fine. Sophia advised she was in the bath earlier and had no knowledge of any fight or altercation.

Based on the above investigation, I find Probable cause to charge the defendant Danielle Simmons with one count of Burglary Battery according to F.S.S. 810.02(2)(A), one count of Simple Battery (Domestic Violence) according to F.S.S. 784.03(1)(A)(1), and one count of Simple Battery according to F.S.S. 784.03(1)(A)(1).

Simmons was placed under arrest, placed into handcuffs, double locked, and checked for Simmons was then transported to BBPD booking and later TOT PBCJ without incident.
