<p>I RESPONDED TO THE BANYAN LAKES CLUBHOUSE PARKING LOT LOCATED AT 8207 SEVERN DRIVE IN UNINCORPORATED BOCA RATON, FL. 33433 IN REFERENCE TO A DISTURBANCE.</p> <p>UPON ARRIVAL, I MADE CONTACT WITH THE COMPLAINANT NELSON PEREZ WHO ADVISED THAT HE WAS JUST INVOLVED IN A PHYSICAL ALTERCATION WITH A W/M WHO HE BELIEVES RESIDES IN THE BANYAN LAKES DEVELOPMENT. AS I WAS SPEAKING WITH PEREZ, I OBSERVED THAT HE WAS WEARING A WHITE DRESS SHIRT WITH A VISIBLE SECURITY PATCH SEWN ON THE FRONT OF IT. PEREZ SHOWED ME HIS VALID SECURITY GUARD LICENSE AND TOLD ME HE WAS THE OPERATIONS MANAGER FOR SOUTH FLORIDA SECURITY GROUP AND WAS WORKING IN THE COMMUNITY WHEN THE INCIDENT OCCURRED. PEREZ PROVIDED BOTH VERBALLY AS WELL AS IN A SWORN WRITTEN STATEMENT AS TO HIS ACCOUNTS OF WHAT OCCURRED AND THEY ARE AS FOLLOWS (START OF STATEMENT): AT APPROXIMATELY 1310 HOURS, I NOTICED A WHITE COROLLA PARKED NEXT TO ME IN THE CLUBHOUSE PARKING LOT OCCUPIED BY A B/M WHO WAS SITTING IN THE DRIVERS SEAT AND A W/M WHO WAS SEATED IN THE FRONT NEXT TO HIM. I OBSERVED THE WHITE MALE TAKE OUT A PIPE AT WHICH POINT I EXITED MY VEHICLE AND SMELLED THE ODOR OF POT. I THEN BEGAN TO TAKE PICTURES OF THE SUBJECTS VEHICLE ALONG WITH ITS LICENSE PLATE WITH MY PHONE AND AS I WAS DOING SO THE W/M EXITED THE VEHICLE AND APPROACHED ME IN AN AGGRESSIVE MANNER. HE THEN GOT IN MY FACE AT WHICH POINT HE PROCEEDED TO SLAP MY HAND IN AN ATTEMPT TO KNOCK THE PHONE DOWN BUT WAS MET WITH NEGATIVE RESULTS. THE SUBJECT THEN RAN BACK TO THE CAR WHICH HE WAS PREVIOUSLY IN AND LEFT THE AREA AND HIS WHEREABOUTS AT THIS TIME ARE UNKNOWN (END OF STATEMENT).</p> <p>PEREZ DESCRIBED THE SUBJECT WHO COMMITTED THE BATTERY ON HIM AS A W/M IN HIS TWENTIES, APPROXIMATELY 6'0 TALL WEIGHING 200 POUNDS WITH SHORT BROWN HAIR. PEREZ SAID THE SUBJECT WAS WEARING A GRAY T-SHIRT WITH BROWN SHORTS AND SANDALS. PEREZ BELIEVES THAT THE SUBJECT RESIDES IN THE COMMUNITY BUT IS NOT CERTAIN ON HIS EXACT ADDRESS. PEREZ TOLD ME THAT THE CLUBHOUSE HAS SURVEILLANCE CAMERAS INSTALLED THAT CAPTURED THE INCIDENT WHICH WILL TAKE SOME TIME TO REVIEW BUT HE SAID WILL CONTACT THE PBSO WHEN THEY ARE READY TO BE OBTAINED. PEREZ WAS ABLE TO PROVIDE ME WITH A TAG NUMBER FOR THE VEHICLE (W97-9UV) THAT THE SUBJECT GOT INTO WHICH FLED THE SCENE.</p>

I THEN ALONG WITH D/S WINK #8778 WHO RESPONDED AS A BACK UP UNIT ARRIVED ON SCENE WHERE WE MADE CONTACT WITH MR. MAXIME WHO HAD ALSO JUST ARRIVED IN HIS VEHICLE. PRIOR TO D/S WINK AND I ASKING MAXIME ANY QUESTIONS AS WELL AS HIM GIVING ANY STATEMENTS, HE WAS READ MIRANDA WARNING WHICH UPON COMPLETION OF IT, ACKNOWLEDGED THAT HE UNDERSTOOD. I THEN PROCEEDED TO ASK MAXIME IF HE HAD ANY INFORMATION THAT HE DIDNT PROVIDE ME WITH ON THE DAY OF THE INCIDENT WHEN I INITIALLY SPOKE WITH HIM THAT WOULD BE BENEFICIAL IN SOLVING THIS CASE. MAXIME SAID THAT ON THE DAY IN QUESTION, HE AND HIS FRIEND WHO HE ONLY KNEW AS DANIEL WERE IN HIS VEHICLE IN THE BANYAN LAKES CLUBHOUSE PARKING LOT SMOKING MARIJUANA. MAXIME SAID DURING THAT TIME, HE DID OBSERVE A SECURITY GUARD TAKING PICTURES WITH HIS PHONE OF HIM AND DANIEL AS THEY SAT IN HIS CAR. MAXIME SAID THAT DANIEL WAS MAD AT THE SECURITY GUARD FOR TAKING THE PICTURES, SO HE EXITED THE VEHICLE AND WENT TO SPEAK WITH HIM. MAXIME SAID THAT DANIEL CAME BACK A SHORT TIME LATER AND GOT BACK IN HIS VEHICLE AT WHICH POINT THEY LEFT THE AREA. MAXIME SAID THAT HE DROPPED DANIEL OFF A SHORT DISTANCE AWAY FROM HIS HOME WHICH WAS IN THE SAME DEVELOPMENT. MAXIME SAID THAT HE WAS UNAWARE THAT DANIEL COMMITTED ANY CRIME WHEN HE CONFRONTED MR. PEREZ AND THOUGHT THEY JUST HAD A CONVERSATION WITH EACH OTHER. I THEN ASKED MAXIME IF HE AND DANIEL WERE ON ANY SOCIAL MEDIA SUCH AS FACEBOOK OR ANY OTHER OUTLETS TOGETHER THAT MIGHT PROVIDE DANIEL'S LAST NAME. MAXIME SAID THAT DANIEL'S LAST NAME MIGHT BE LISTED ON HIS FACEBOOK AS HE AND HIM ARE LISTED AS "FRIENDS." MAXIME'S FACEBOOK PAGE DID HAVE A DANILLO WITH THE LAST NAME OF SANTOS LISTED AS ONE OF HIS FRIENDS THAT DID MATCH THE DESCRIPTION OF THE SUBJECT IN THE SURVEILLANCE VIDEO. I HAD NO OTHER QUESTIONS FOR MAXIME AS HE WAS RELEASED ON HIS OWN RECOGNIZANCE WITHOUT INCIDENT.</u></p>

I THEN WITH THE ASSISTANCE OF D.A.V.I.D PREPARED A PHOTO LINE UP FOR THE VICTIM IN THIS CASE TO IDENTIFY THE SUSPECT THAT COMMITTED THE BATTERY. AT 1205 HOURS, D/S DUTTENHOEFFER #6387 AND I RESPONDED TO THE BANYAN LAKES CLUBHOUSE WHERE WE MADE CONTACT WITH MR. PEREZ IN REFERENCE TO A PHOTO LINE UP. D/S DUTTENHOEFFER WHO IS NOT FAMILIAR WITH THE INVESTIGATION ADMINISTERED THE PHOTO LINE UP TO PEREZ WHICH I WAS NOT PRESENT IN THE SAME ROOM FOR. PEREZ SELECTED AND CIRCLED PHOTO #5 AND CONFIRMED IT WITH HIS SIGNATURE AND DATE. THE SELECTED PERSON BY PEREZ IS POSITIVELY IDENTIFIED AS DANILLO SANTOS. THE FOLDER AND THE PHOTO ARRAY PRESENTED TO PEREZ WAS LATER PLACED INTO PBSO EVIDENCE.
