PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

I did not observe a driving pattern of the vehicle. I was dispatched to a motor vehicle crash involving two vehicles. One vehicle, driven by the defendant, was rear ended due to being stopped in the middle of the road. The defendant provided me a statement which was recorded via my body worn camera. The defendant stated he was driving home from a holiday party where he consumed two beers.

OBSERVATION OF DRIVER:

When I made contact with the driver I could smell the distinct odor of an unknown alcoholic beverage. The defendant had slurred speech. The defendants eyes were glossy, blood shot and watery.

DRIVER'S STATEMENTS:

The defendant stated he was leaving a holiday party in PGA National. The defendant stated he was driving his vehicle home from the party. The defendant stated he had two beers at the party. The defendant stated the open container in the vehicle belonged to his passenger. The beer was located on the driver side floor board.

ODORS:

The odor of unknown alcoholic beverage was detected on the defendants breath.

Other Observations:

WALK & TURN:

The defendant had issues getting into the starting position. The defendant did not remain in the starting position as instructed. I observed the defendant to sway while the instructions were being given, miss heel to toe and step off the line during the task. The defendant raised his arms for balance, turned incorrectly and took the incorrect number of steps. The defendant took 10 steps in each direction. The defendant also asked questions during the task.

ONE LEG STAND:

I observed the defendant to sway while in the starting position. The defendant put his foot down during the task and raised his arms for balance. The defendant failed to raise his for six inches from the ground during the task. The defendant jumped from eight to 10 while counting out loud.

FINGER TO NOSE:

The defendant failed to get into the starting position and had issues maintaining the starting position. The defendant failed to tilt his head back after being instructed to do so. The defendant failed to touch the tip of his finger to the tip of his nose. All attempts the fingers touched the area between the nostrils under the tip of the nose.

ROMBERG/ALPHABET:

The defendant failed to remain in the starting position as instructed. The defendant recited the alphabet incorrectly from the letter D. The defendant attempted the alphabet a second time and recited it incorrectly.
