<p>On 5/21/2017 approximately 2047 hours, I responded to 22599 SW. 65th Ave. located in unincorporated Boca Raton, FL 33428 reference to a domestic dispute.</p>									
<p>Upon arrival, I met with the victim who was identified by her Florida driver's license as Shari Sanchez. she stated the following: Her and her husband of 12 years, who she verbally identified as Dario Salto, we're watching TV with their children in their living room. After the TV show was over, she put their kids to bed and got on her laptop computer to finish some homework. When Dario saw that she was working on homework instead of spending time with him, he got very upset. He told her that it was the only time they have to spend together, and that she always waits till the last minute to finish her homework. Out of anger, he told her to go to their bedroom to finish her homework. Minutes later, Dario came to their bedroom, began pushing her and arguing with her about not spending time together.</p>									
<p>When Dario saw that she was on her cell phone, he started to yell at her saying, she's is always on her phone for social media. Shari advised that Dario then pushed her with two hands on the chest four times. Shari became afraid, telling him to stop or she was going to call the police. Dario continued to follow her around the residence, as she was trying to walk away to defuse the situation. Dario attempted to grab her cell phone to see who she was calling. Shari would not allow him to grab the phone, which upset Dario, because he felt like she was hiding something from him. Shari started to yell and scream to make Dario stop fighting with her, Dario grabbed her mouth with his left hand in an attempt to quiet her, but could not fully cover her mouth because she kept moving away. Shari ran outside to call 911. When Dario saw that she was calling 911 he got into his Gray 2013 Ford F-150 truck bearing FL tag HAJI96 and left the residence to an unknown location.</p>									
<p>I observed red marks on Shari's chest where she was pushed by Dario. While Shari was explaining what occurred, she began crying on multiple occasions. I made multiple attempts to contact Dario but was met with negative results. Due to Shari feeling unsafe sleeping in the residence, she took her three children whom they share in common and went to stay with her family in the city of Coconut Creek.</p>									
<p>Based on Shari's statements provided and red marks on her person where she was pushed, I have probable cause to arrest Dario Salto under F.S.S 784.03(1) (A) (1) Simple Battery (Domestic).</p>
