PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)
Witness stated Drake was driving in the alleyway behind the plaza, rear ended a white Lexus and then backed up, and parked his vehicle. Drake then stumbled out of his vehicle and went inside Cheese Burgers and more restaurant. See recorded statement from witness, W/F Madisen C. Bush. which was recorded on my Body Worn Camera for driving pattern.

OBSERVATION OF DRIVER:

Drake had glassy eyes. Drake had great difficulty focusing and his movements were slow and uncoordinated. Drake had difficulty focusing and trailed off while answering questions. While standing he was swaying and would close his eyes as it appeared he was going to fall asleep. His movements were slow and clumsy.

DRIVER'S STATEMENTS:

Drake had extremely slurred speech and had a hard time answering simple questions. He would start answering a question and then trail off. He stated he was at the front of the plaza, drove around to the back and then crashed into a parked vehicle. He then parked his car and went inside the restaurant.

ODORS:

Noticeable odor of an unknown alcoholic beverage on Drake's breath which got stronger as he spoke.

GENERAL OBSERVATIONS

SPEECH: Slow, slurred, mumbled. Often incoherent

ATTITUDE: He went from polite to angry.

CLOTHING: Grey shirt and grey pants which were wet.

MEDICAL/OTHER: Stated he takes medication for cancer.

WALK & TURN

Drake lost his balance during instructions. He began the task before being told to start. He could not maintain the position during the instruction phase. He missed the heel to toe on all steps and came off the line on number 3,4,5. He then stopped midway into the task and used his arms to regain his balance. In his walk back he did not touch heel to toe on any of the steps.

ONE LEG STAND:

He was given the instructions, stated he understood his left from his right and began the task. Once he lifted his left leg, he began to count and put his leg down, and lost his standing position. He restarted the task, lifted his leg and once again fell off from his standing position, putting his leg down. He had to use his arms for balance in order to not fall down.

FINGER TO NOSE:

Stated he could not put his feet together. I had to repeat the instructions several times. The instructions were given in the following order. L,R, L,R,R,. He had to be reminded to bring his hand back to his side on second left, and second right.

ROMBERG ALPHABET:

Stated he could not put his feet together. Once he started the task his alphabet order was as follows:
A,B,C,D,E,F,G,H,I,J,K,L,M,O,P,Q,R,S,T,U,V,W,X,Y,Z.
