On the above date and time, I Trooper Kuebler, I.D #1488, heard a BOLO over the radio by the Lake Worth Regional Communications Center (LWRCC), that there was a Broward County Sheriffs Deputy behind a vehicle that was all over the road and failure to maintain its single lane northbound on SR-91 (FL Turnpike) at the 77 mile marker. I advised LWRCC that I was going to be in route to the BOLO to

try to intercept the vehicle. LWRCC advised that the Broward County deputy was updating the mile markers as he was following the vehicle that was all over the road and unable to maintain its lane. I Trooper Kuebler, advised LWRCC that I was going to be stationary northbound at the 86 mile marker on the right hand paved shoulder of the roadway. At 9:21 PM, I was able to get a visual on the vehicle that the Broward County deputy was following. The vehicle at the time, was a silver BMW with a bearing Florida tag (GVJY46), that was traveling in the outside/right hand lane on SR-91. I Trooper Kuebler was able to get behind the vehicle, which was the silver BMW that passed my location northbound on SR-91 off the right hand paved shoulder of the roadway. As I was behind the vehicle, I observed the silver BMW to be traveling at a slow rate of speed in a 65 mph zone. The silver BMW was traveling around approximately 50 mph and then would decrease its speed to approximately 40 to 45 mph. I observed the silver BMW while following behind the vehicle, to swerve and Vere off the right hand paved shoulder of the roadway. The right side of the silver BMW had gone off over the white line and onto the right shoulder as I was observing the vehicle.

At that time, I conducted a traffic stop on the vehicle for failure to maintain a single lane on the northbound exit ramp to SR-804 (Boynton Beach Blvd) from SR-91 at the 86 mile marker, off the right hand grassy shoulder. When I made contact with the driver, I observed the drivers eyes to be very bloodshot. I asked the driver to step out of the vehicle to speak with him. I identified the driver of the silver BMW by his by his Florida drivers license, (G-432-167-84-088-0) as Mr. David Gordon Goldstein. As I was speaking with Mr. Goldstein, I observed again that his eyes were very bloodshot. I asked Mr. Goldstein where he was headed to and he stated he was in the process of moving. I observed Mr. Goldstein to be confused at times while making contact with him. I observed Mr. Goldstein to be a little uneven on his feet as I was speaking with him. I told Mr. Goldstein that I was going to be taking him to the toll booth off the exit ramp to SR-804 from SR-91 to conduct filed sobriety exercises due to the suspicion of driving under the influence of alcohol and or narcotics. At 9:38 PM, I arrived at the toll booth parking lot to conduct field sobriety exercises on Mr. Goldstein. I asked Mr. Goldstein if he had any medical conditions which would prevent him in conducting the exercises, in which he sated no.

The first exercise I had Mr. Goldstein perform was the Horizontal Gaze Nystagmus Exercise. I explained the exercise to Mr. Goldstein, and then began to perform the exercise. As I made my first pass to the left and back to the right, I was checking Mr. Goldstein's eyes for equal tracking and equal pupil size. I observed Mr. Goldstein had minimal distinct and distained nystagmus at maximum deviation in both eyes. There was no vertical nystagmus that I could observe through the vertical gaze nystagmus exercise.

The next exercise I had Mr. Goldstein perform was the Walk and Turn. I explained to Mr. Goldstein how to properly perform the exercise, as well as I demonstrated myself how to perform the exercise to Mr. Goldstein. Mr. Goldstein told me that he understood when I asked him. Upon starting the exercise Mr. Goldstein had a hard time maintaining his balance throughout the exercise while acting jittery. Mr. Goldstein had a hard time properly making correct contact with both his feet together while doing the exercise. Mr. Goldstein while making his ninth step, had a hard time making the pivot to turn back around to continue with the nine steps. Mr. Goldstein kept on trying to start the exercise before I told

him to do so.

The next exercise I had Mr. Goldstein perform was the One Leg Stand. I explained to Mr. Goldstein how to properly perform this exercise, and also I demonstrated myself to Mr. Goldstein on how to properly perform the exercise. Mr. Goldstein understood the exercise. Upon starting the exercise, Mr. Goldstein had a hard time balancing on one leg. Mr. Goldstein would constantly put down his foot during the exercise and pick it back up again. Mr. Goldstein would sway back and forth and would not pick his foot up in the proper manner as he was instructed to do so. Mr. Goldstein had a hard time balancing on one leg for the remainder of the exercise.

At the conclusion of my field sobriety exercises, I Trooper Kuebler concluded that Mr. Goldstein was impaired enough to not be able to operate a motor vehicle. At 9:54PM, I placed Mr. Goldstein under arrest for the suspicion of driving under the influence of alcohol and or narcotics. At 9:58 PM, I transported Mr. Goldstein to the Palm Beach County Jail. At 10:16 PM, I arrived at the Palm Beach County jail where I conducted a 20-minute observation of Mr. Goldstein, where he did not drink or ingest any foreign objects. After the conclusion of the 20 minute observation, Mr. Goldstein was willing to apply a breath sample. The first breath sample was 0.00. The second breath sample was 0.00. At that time, I requested Mr. Goldstein to supply a urine sample due to the suspicion of drugs and or a controlled substance. Mr. Goldstein agreed to provide a urine sample at that time. The urine sample will be shipped to the Palm Beach County Lab for testing of a controlled substance and or drugs. At this time Mr. Goldstein was charged with Driving under the Influence of a Controlled Substance and or Drug. Mr. Goldstein was booked into the Palm Beach County Jail. At this time, I will be waiting for the lab test results from the urine sample Mr. Goldstein gave me. All these events occurred in Palm Beach County. No further information at this time.



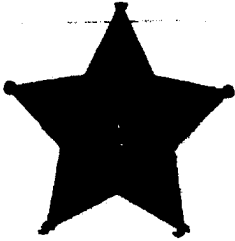

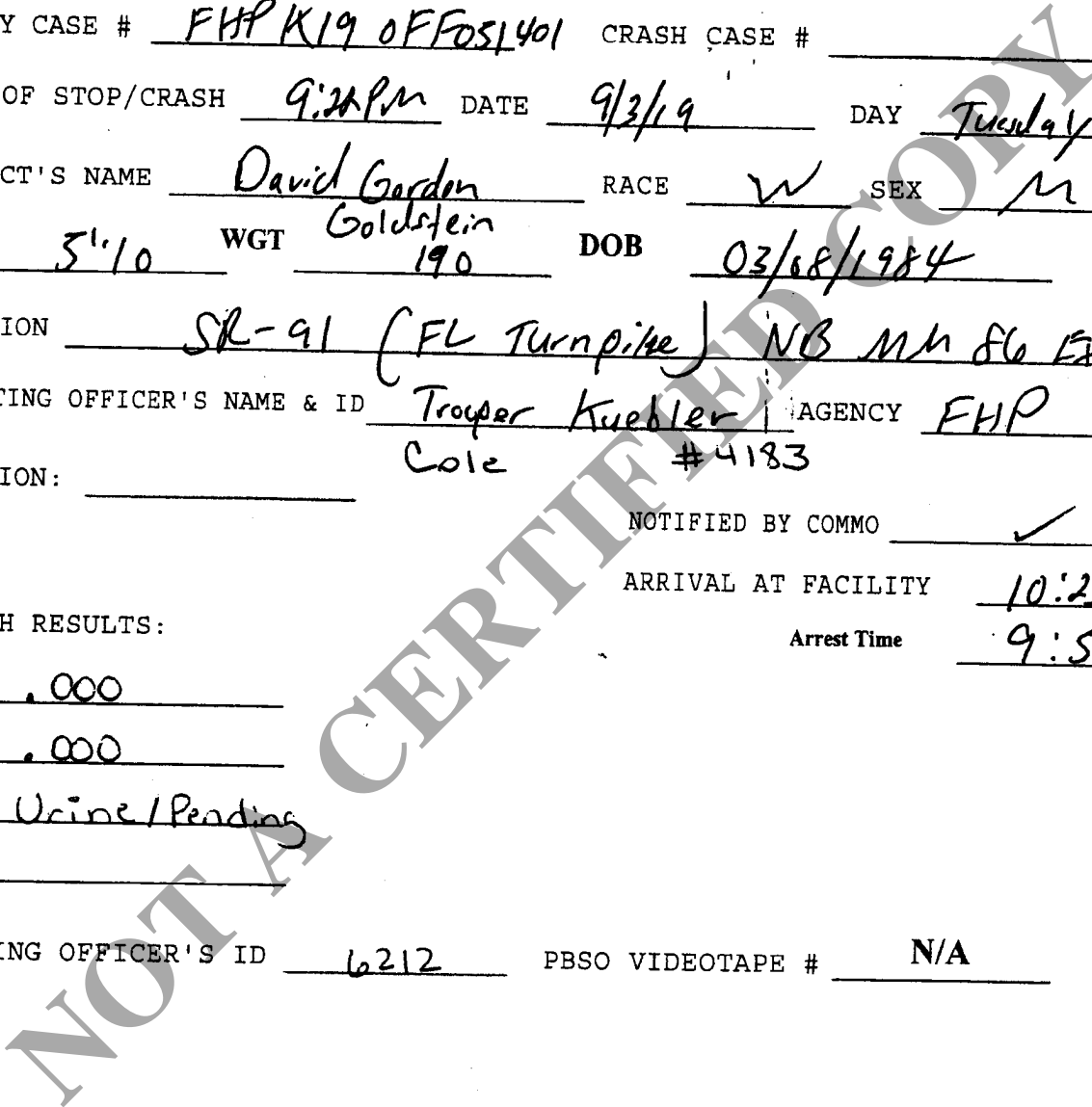
