PERSONAL CONTACT

NARRATIVE:

I was dispatched to domestic/battery call at 4241 Lake Worth Road (Home Depot). Dispatch stated a white male was strangulating a white female. Ofc. Hite #155 and I were en route to the call. Ofc. Hite arrived on scene first and made contact with the victim, later identified as Mrs. Tabitha Yvette Nealis, who was sitting in her vehicle (a silver Chrysler Town and Country minivan). Nealis stated her husband, Mr. David Lee Lamb Jr, strangled her while she was sitting on the front passenger seat. Lamb left the area and ran eastbound on Lake Worth Road. A witness stated he ran towards Beverly Drive. I performed a BOLO of Lamb. Dispatch stated he was wearing a white t-shirt and camouflage pants. I was flagged down by two witnesses who observed the incident. I made contact with Mr. Angel Daniel Rivera, who is a Home Depot employee, and another witness Mr. Sergio Jaime Guzman Madriaga, at the corner of Lake Worth Road and Beverly Drive. They observed Lamb walking northbound towards Lakewood Road. I observed Lamb, who matched the clothing description, at the intersection of Lakewood Road and Beverly Drive, and then make an abrupt left from Lakewood Road. I activated my overhead blue lights and took out my Taser. I told Lamb "STOP". I exited my vehicle and told Lamb to get down on his knees. Lamb complied. Ofc. Hite left Nealis on scene and was en route as backup officer. I placed Lamb in handcuffs (double locked and checked for tightness). I spoke with my first witness Rivera. Rivera stated he was walking in the parking lot, when he observed Lamb choking his wife while in their vehicle. Rivera stated Nealis was crying. Rivera stated he called the police. I made contact with Guzman. Guzman stated he was parked next to Nealis' vehicle, when he observed Lamb choking Nealis. Guzman stated he went to Home Depot to call the police. I told Nealis he is under arrest for Aggravated Battery. Ofc Hite transported lamb to the police station. I made contact with Nealis at her home (341 Midpines Road). Nealis stated Mary Lamb (David Lamb Jr's mother) was the driver. Mary was inside the store when the incident occurred, and she did not observe when her son choked Nealis. I observed redness around Nealis' neck. Nealis stated Lamb grabbed her, choked her, and then stabbed the left side of her head with a key. I observed blood and a mark on the left side of her scalp. I took photos of Nealis' injury. A videotaped statement was performed.

DEFENDANT'S STATEMENTS: (Written / Taped / Oral)

Defendant was read Miranda Rights, which he understood and signed. Defendant refused to give a videotaped statement or talk about the incident.

VICTIM'S STATEMENTS: (Written / Taped / Oral):

Victim stated they met in May 2016. They got married on November 2016. Victim stated they do not have any children in common. Victim stated her husband has hit her in the past. Victim did not dial 911 when she was being assaulted. Victim stated Lamb took her cellphone so he can read her texts, and see who was calling her. Victim stated her husband is on probation for Felony Battery. Victim stated her husband hit his sister when she used to reside at the house. She no longer resides at the residence.

OBSERVATIONS OF VICTIM (PHYSICAL AND EMOTIONAL)

Redness around the left side of her neck. Dried blood on the left side of her scalp, under her hair.
