NARRATIVE:

I am part of a National Task Force known as the South Florida Internet Crimes against Children (ICAC). This task force investigates internet crimes against children, child exploitation, and related cases.

Between the dates of May 2019 to July 2019, FBI Special Agent [REDACTED] located an Internet Protocol (IP) address 73.0.15.75 Port 48022 in a database maintained by law enforcement, and utilized by federal and state law enforcement agencies in child exploitation investigations nationwide. This database maintains a log of IP addresses that have been previously involved in the possession and distribution of videos/images involving the sexual conduct of a child.

I reviewed 6 images out approximately 675 videos Special Agent [REDACTED] downloaded directly from the user at the above IP address. These files depicted child pornography as defined by Florida Statute. Some of the images involved the sexually explicit depiction of children but did not meet the definition of child pornography.

A search of a publicly available online database indicated that the target IP address was registered to Comcast Internet Services. On September 17, 2019, I sent a subpoena issued to Comcast Internet Services for the identity of the subscriber assigned to IP address 73.0.15.75 Port 48022 on the date range the files were downloaded by Agent [REDACTED]

On September 17, 2019, Comcast revealed that on the dates of the downloads, of the IP address was assigned to the following Comcast customer, David Robinson at 2825 SW 22nd Avenue, Apt. 203, Delray Beach, FL 33445.

I located David Robinson in the Driver and Vehicle Information Database reported to reside at 2825 SW 22nd Avenue, Apt. 203, Delray Beach, FL 33445.



On September 24, 2019 Honorable Judge Caracuzzo granted a residential Search Warrant for address 2825 SW 22nd Avenue, Apt. 203, Delray Beach, FL 33445.

NARRATIVE CONTINUATION

On September 27, 2019, the search warrant was executed and contact was made with David Robinson. Post Miranda, Robinson admitted to installing file sharing software on his computer. Robinson further admitted to downloading and viewing several files, which involved the sexual conduct of a child. Robinson explained the last time he viewed child pornography was one week ago. He stated, "I know it's wrong," "I hate the thoughts," "It's a secret in my mind," "I need help." Robinson stated his account is always logged on. He watches child pornography once or twice a week. Robinson stated he custom built his computer, which housed multiple harddrive and categorizes his child pornography into subfolders.

An on scene preview of Robinson's computer revealed numerous images/video involving the sexual conduct of children. Some of these images depicted children that appeared to be between the ages of infant to approximately six years old.

David Robinson did possess 30 images containing the sexual conduct of a child violating FSS 827.071(5) and one count of Possession of Material Depicting Sexual Performance by a Child with Intent to Promote F.S.S 827.071(4) and one count Transmission of Pornography by Electronic Device F.S. 847.0137.
