<p>N Gonzalez advised that she went out drinking after work with several male co-workers. When they dropped her home at the above address, her boyfriend, David Hanson (W/M 8/8/86), exited the residence and began an argument. At some point in the argument, Hanson pushed Gonzalez to the ground. Hanson entered the residence and emerged with a firearm. Hanson again pushed Gonzalez the ground and pointed the firearm at her head. Gonzalez had a small cut on the bridge of her nose which she advised was from Hanson putting the gun to her head. She advised that he did not hit her with the firearm but that the cut was caused by it. At some point loud noises where heard which were possibly gunshots but nothing was seen. Gonzalez described the firearm as a silver handgun. Gonzalez provided a sworn statement.</p> <p>Contact was made with a witness, Arturo Quiros (H/M 4/1/83), who advised that he and several co-workers went out after work. Upon arrival to Gonzalez's residence, Hanson exited the residence and began an argument with Gonzalez. Hanson struck Gonzalez and Quiros attempted to intervene. Hansen entered the residence. Quiros heard two loud noises which he initially believed to be fireworks. Hanson came back with a silver firearm which Quiros thought was a revolver. Hanson pointed the firearm at Gonzalez and Quiros again attempted to intervene. Hanson pointed the firearm at Quiros. Quiros directed another witness, Michael Salha (H/M 9/8/81), to call 911. After seeing the firearm Quiros thought the noises may have been gunshots. Quiros provided a sworn statement. Quiros did not wish to press charges against Hanson for pointing the firearm at him but left the area before he could sign a refusal to prosecute.</p> <p>Salha described the same series of events as Gonzalez and Quiros. Salha did not wish to provide a sworn statement.</p> <p>The firearms belonged to Hanson's father, David Hanson Sr (W/M 10/6/56), who signed a consent to search. A silver semi-automatic handgun was located, .45 caliber Smith and Wesson model 4506 Serial # TCD4769, which matched the description from the victim and witnesses. The firearm was collected and placed into evidence by Ofc Vautin (See his supplement for further).</p> <p>Post Miranda Hanson advised that he was angry the Gonzalez was out late with her co-workers due to the fact that she has cheated on him before. He told Gonzalez to "leave him alone". He advised that the argument never became physical and he never brandished a firearm. Hanson advised that he did state to Gonzalez that he had a firearm. Hanson advised that the loud noises were fireworks which he set off to scare Gonzalez and her co-workers away. It should be noted that several casings of fireworks were found in the yard and no one advised they witnessed a firearm being discharged.</p> <p>Gonzalez and Hanson both stated that they have been in a dating relationship for approximately one year and they have been living together for approximately eight months.</p> <p>Based on the above facts I find that David Hanson did actually and intentionally touch or strike Danielle Gonzalez against the will of Gonzalez and/or did intentionally cause bodily harm to Gonzalez and Gonzalez was a family or household member or a person in a dating relationship with David Hanson contrary to Florida Statute 784.03(1) and that Hanson did intentionally and unlawfully threaten by word or act to do violence to the person of Gonzalez, coupled with an apparent ability to do so, and did point the firearm at her, which created a well-founded fear in Gonzalez that such violence was imminent, contrary to Florida Statute 784.011 and during the commission or attempt to commit any offense listed in Florida Statute 775.087(2)(a)1, Hanson actually possessed a firearm or destructive device, as those terms are defined in section 790.001, Florida Statutes, the firearm or destructive device being a deadly weapon, contrary to Florida Statutes 784.021(1)(a).</p>
