On the **20** day of **April**, **2018** at **21:40** (Specifically include facts constituting cause for arrest.)

On 04-20-2018 at approximately 1940 hours, I responded to 260 SW 7th St. apartment 19 in reference to a disturbance. BRPD dispatch advised the caller, Jorge Rodriguez, advised his tenant (Dawn Ferrari) was causing some issues inside the apartment and needed BRPD to respond. I spoke with Rodriguez via landline about the issue at hand. Rodriguez advised Ferrari was urinating inside the apartment hallway and was concerned for her wellbeing.

Upon arrival, Officer Saavedra and I made contact with, W/F Dawn Ferrari inside apartment 19. It should be noted, during our interaction with Ferrari, she appeared to be highly intoxicated. Ferrari had trouble standing, her speech was slurred, her eyes were glassy and red, there was a strong odor of alcohol coming from her breath. Ferrari advised she had been drinking and had consumed half a bottle of white wine. I went to speak with W/M John Orsini and had Officer Saavedra stand by with Ferrari outside the apartment.

While speaking with Orsini about the incident inside the apartment, Officer Saavedra advised Ferrari had battered W/M Martin Husak. Officer Saavedra explained Husak was about to enter his apartment (20) which is adjacent to apartment 19. In Officer's Saavedra's presence, Ferrari approaches Husak and hugs him. Ferrari is then seen kissing Husak's neck and which caused Husak to feel uneasy. Officer Saavedra then asked Husak if he knew her, Husak advised he did not know her.

I spoke with Husak about the incident. Husak advised he had just got home and was about to enter his apartment when Ferrari approached him. Husak advised Ferrari hugged him and kissed his neck. Husak advised he is a foreign exchange student and was unsure on what was going on. Husak advised the interaction was unwanted and he did not give her permission. Husak provided a sworn written statement.
