PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 1/5/18 at 10:41 p.m. I was running laser on PGA Blvd at Kidd Lane sitting in the parking lot of 2352 PGA Blvd. Officer Koegel was sitting next to me during the traffic enforcement. I observed a black sedan traveling eastbound on PGA Blvd in the left lane from Prosperity Farms, a posted 40 mile per hour zone. I visually estimated the vehicle to be traveling at 60 miles per hour. I used my Stalker laser and positioned the red dot on her car and obtained a visual reading of 58 miles per hour in the 40 mile per hour zone. I advised Officer Koegel that the black sedan was traveling at 58 and he exiting the parking lot to stop the black sedan. Officer Koegel also observed that as the black Lexus made a left turn she nearly struck a curb.

OBSERVATION OF DRIVER:

Officer Koegel approached the vehicle from the passenger side and made contact with the white female driver and sole occupant. I walked up to the drivers side. Officer Koegel asked the driver for her license, registration and proof of insurance. Officer Koegel observed that the driver, Dawn Mansur, had slurred speech and she had delayed movements and statements. I smelled a strong odor of an unknown alcoholic beverage on her breath as she spoke, her speech was slurred, her eyes were red and glassy, her face flush and she was repeating herself. When she exited she was unsteady on her feet, swaying the entire time. She was

having mood swings from cooperative to belligerent. Mansur stated she had one glass of wine then as she was walking into the bat she stated she had 2 glasses of wine. Mansur stated she had two teeth drilled at 2 p.m. today.

ODORS:

strong odor of an unknown alcoholic beverage coming from her breath as she spoke

SPEECH: slurred

ATTITUDE: mood swings, cooperative to belligerent

CLOTHING: black pants, black top, black boots

MEDICAL/OTHER: two teeth drilled



demonstrated and explained she said she understood, she started walking twice before told to, she was not standing heel to toe during the instructions, she was not walking heel to toe, she stepped off the side, she stopped after 9 steps, asked what to do, I advised her to turn like instructed and take 9 steps back, she spun around not as instructed and took 9 steps back none heel to toe, stepping off to the side.

did not have her perform task

FINGER TO NOSE:

demonstrated and explained she said she understood, she stated she was cold and her hand was already shaking, I advised her to do the best she could, she was swaying entire time, touched the side of her nose and under her nose, used wrong hand once.

ROMBERG/ALPHABET:

demonstrated and explained she said she understood. I asked her if she knows the alphabet from a-z forward and she said no. Then she stated she knows the alphabet. She recited most of the alphabet correctly until the end and jumbled the letters.


