On the **8** day of **December**, **2019** at **19:27** (Specifically include facts constituting cause for arrest.)

The following incident occurred in the City of Delray Beach, Palm Beach County, Florida.

Officers responded to 1841 S Federal Hwy, Harvest Grill's Parking lot, in reference to an active disturbance between a group of five subjects. When officers arrived on scene, Ofc. Hutchens observed a white female, later identified as Deana Canestro (offender), behind some bushes in the parking lot. Ofc. Hutchens directed her to put her hands up and she refused to comply which is when Ofc. Hutchens took her in custody and placed her in handcuffs. Officers then made contact with Stephen Sabella (victim) and Sienna Sabella (victim's daughter and witness).

The following recount of events was given by St. Sabella and Si. Sabella in sworn recorded statements: St. Sabella stated that he invited Canestro to the Harvest Grill for a couple of drinks to work things out as they broke up a couple weeks back. St. Sabella stated that as they were leaving, he noticed the keys to his Nissan Altima were missing from the bar countertop. St. Sabella stated that he then confronted Canestro about her taking his car keys. Canestro then began waving the car keys at his face and stated she wasn't going to give it to him. Lara Corrente (Canestro's friend) then took Canestro to her salon. While Canestro was at her salon, St. Sabella then called Canestro to come back to give him back his key. Canestro then went back to the scene where Canestro's daughter and daughter's boyfriend met up with her. Si. Sabella responded to the scene as well since St. Sabella called her to take him home. All parties meet on scene and due to previous history of disagreements between Si. Sabella and Canestro they began arguing over St. Sabella's car keys that were missing. St. Sabella got in the middle of Si. Sabella and Canestro as they were arguing and eventually St. Sabella went to the white Range Rover (FL Tag LXWD23) that Si. Sabella's came in. St. Sabella then grabbed a tire iron from the Range Rover to break his window of his Nissan Altima so that Canestro could not take his Nissan since he believed that Canestro had his keys. St. Sabella eventually put down the tire iron on top of the white Range Rover without

smashing out his window to the Nissan as Canestro went back to fighting with Si. Sabella. Canestro eventually grabbed the tire iron and St. Sabella told Si. Sabella to run into Stein Mart and call for the police. Both St. Sabella and Si. Sabella saw as Canestro was swinging the tire iron and eventually smashed the back windshield of the Range Rover causing approximatley \$500 in damage. Canestro then went inside the Range Rover as it was still on from when Si. Sabella parked it to help her father. Canestro reversed the vehicle out of the parking spot even though it was registered under St. Sabella's name and she never owned or was given permission to drive the vehicle. Canestro eventually left the vehicle running in the middle of the parking lane and ran away from it. Directly afterwards, Officers arrived on scene and detained Canestro. An independent witness (Robert Hubler) was on scene and stated the following in a sworn recorded statement: Hubler stated that when he was going into the parking lot he saw Canestro swinging the tire iron in the air and eventually smashed out the back windshield to the Range Rover. Canestro then entered the vehicle and backed it out of the parking space. Hubler did not witness what took place prior to this. Canestro gave a statement Post-Miranda but was obviously intoxicated and was rambling and not given concise answers. Canestro stated that she was being chased with the tire iron by Si. Sabella, but was hostile and failed to comply with officers throughout her entire encounter. Canestro also stated that she broke up with St. Sabella about a month prior, but she has driven the Range Rover prior. Canestro was arrested and transported to the THF. Ofc. Reinhart was conducting a female search at the THF and once Canestro was unhandcuffed, she sat down to take off her heels. Ofc. Reinhart instructed her to stand up and take off her shoes in the holding cell but Canestro failed to listen. Ofc. Reinhart then assisted her off the ground at which point Canestro tensed up and got in Ofc. Reinhart's face stating to not touch her like that. Reinhart then began moving her toward the holding cell in fear that a confrontation was going to ensue which is when Canestro then began pulling away from her. I went to assist Ofc. Reinhart and Canestro began pushing and pulling me as well. Canestro then began pulling at my radio causing my radio to be pulled off of my outer vest carrier and causing me to be unable to use it. Canestro was eventually restrained back in handcuffs and during the confrontation Canestro sustained an injury to her left pinkie. Due to the above stated facts, there is probable cause to charge Canestro with Criminal Mischeif (\$200-\$1000) per F.S.S. 806.13(1B2), Grand Theft Auto per F.S.S. 812.014(2C6), Battery on a LEO per F.S.S. 784.07(2B), Deprive LEO from Communication Device per F.S.S. 843.025, and Resisting w/ Violence per F.S.S. 843.01.
