PROBABLE CAUSE

On May 27th, 2017 I Trooper Lucas M. Tavares (3913/1555) with the Florida Highway Patrol was on active patrol in Palm Beach County, Florida. I was in a marked FHP unit equipped with overhead emergency lights and external siren. At approximately 09:15 p.m. I received a call from the Palm Beach County Sheriff's Office in reference to a possible impaired driver, located at N. L St. and Lake Ave. in Lake Worth, Florida.

At approximately 9:22 p.m. I arrived on scene. On scene was Deputy Lonney Moral (#9160) with the Palm Beach County Sheriff's Office. Deputy Moral stated that he saw a white female walk up to a white in color four-door vehicle and attempted to pull out of a parking spot, located on N. L St. facing southbound. Deputy Moral stated that the white female attempted to back out multiple times, while doing so she struck the curb multiple times. Deputy Moral then approached the driver and knocked on the window. He stated that she was verbally combative and refused to step out.

I then came into contact with the driver of the vehicle. Who I later identified to be Deanna Christine Marie by her Florida's Driver's License number: (M600-163-46-871-0). Ms. Marie was standing outside of her vehicle to the rear. I then approached her and asked if everything was alright. She then began to start yelling about how she wants to go home and that she did nothing wrong. I asked her if she was ok and she yelled yes. Ms. Marie had bloodshot and watery eyes. Her speech was slurred and incoherent at some points. I could detect an odor being emitted from her breath that grew stronger as she spoke (yell). I asked her if she had anything to drink and she stated that she had one glass of wine.

Suspect vehicle: 2007 White Ford 4-door, with Florida Tag: (K843FY) attached.

I then asked Ms. Marie if she would perform voluntary field sobriety exercises and she stated she did nothing wrong. I then asked again and she stated that she would because she did nothing wrong.

Standardized Field Sobriety Exercises (SFSE):

The area for the following roadside exercises was level hard surface and was free of debris. The weather was clear.

Horizontal Gaze Nystagmus:

I advised the subject to stand straight with their feet together and arms down by their side. I asked subject if they wear any glasses or contacts, they advised they do for seeing up close. I then asked if that would prevent her from seeing shapes or colors. She stated no. For the exercise I used my issued red pen light and illuminated it with a Streamlight white in color flash light. I asked the subject if they could see the red pen light, they stated yes. The subject was asked about any current medical conditions, they stated that they had a thyroid problem. I advised the subject to follow the red pen light with their eyes and eyes only, and to not move their head. I asked subject if they understood the instructions I gave to them. They stated yes. I asked if they had any questions they stated no.

The following was observed during Horizontal Gaze Nystagmus:

The subject did have resting Nystagmus and dilated pupils.

- LT EYE-LACK OF SMOOTH PURSUIT
- RT EYE-LACK OF SMOOTH PURSUIT
- LT EYE-DISTINCT & SUSTAINED NYSTAGMUS AT MAX. DEVIATION

- LT- EYE-ONSET OF NYSTAGMUS PRIOR TO 45 DEGREES
- RT- EYE-ONSET OF NYSTAGMUS PRIOR TO 45 DEGREES

I had to instruct subject multiple times to keep her head straight and follow the red pen light with her eyes only.

Walk and Turn Exercise:

Interaction Phase:

The area for the following roadside exercises was level and free of debris. Subject agreed to use a white in color traffic line.

I advised the subject to place their left foot on the imaginary line and their right foot directly in front of it, touching heel to toe. I advised the subject to keep their arms down by their side and to stay in that position until I advise them to begin the exercise. This exercise was first explained to the subject then was demonstrated by myself. Subject advised that they would be able to perform the exercise. Subject advised that they had no injuries that would affect the exercise. Subject stated that she had knee surgery, but would not affect the subject from walking a straight line. Subject advised me that they understood instructions and did not have any questions.

The subject could not keep balance while in the starting position. The subject kept stating she can't do it because she is tired. I had to repeat the exercise multiple times to subject. Subject started the exercise before instructed. I could not complete my instructions due to subject not listening.

One leg stand:

-Could not complete do to subject not listening.

Based on the totality of circumstances, Ms. Marie was placed under arrest for DUI pursuant to Florida Statute 316.193.1 at 09:37 PM. While attempting to restrain Ms. Marie she would not give us her arms for restraint. She kept pulling away from us. We then got the hand cuffs on her and I put them on Ms. Marie pretty loose compared to normal arrestee's. Ms. Marie was attempting to pull out of the handcuffs in which she lacerated herself on her right wrist. I then called fire rescue to asses her injury. Fire rescue then wrapped both her wrists with medical wrap and cleared her from scene. Ms. Marie was then placed in Trooper Zion Todd's (1729) patrol vehicle and transported to the Palm Beach County Jail in which she arrived at 10:18 PM. After the defendant's 20min observation, the defendant was then given the opportunity to provide a sample of her breath which she at first refused to provided. I then read implied consent. Ms. Marie then consented to provide. The defendant's first breath was given at 10:48 PM and resulted in a volume not met. The defendant's second breath was given at 10:54 PM and resulted in a 0.140. The defendant's third breath test (Due to volume not met on the first sample) was given at 10:58 PM and resulted in 0.132.

Video of the incident, roadsides and transport are available through the FHP custodian. The above incident did occur in Palm Beach County, Florida.
