On the above date at approximately 1714 hours, I responded to the area of Keystone Drive and Keystone Drive North in reference to a just occurred single vehicle crash.


Upon arrival, it was indicated to me that the driver of the vehicle, Denise Yates, may be intoxicated. Officer Yochum and I decided to split up the crash and DUI investigations. Officer Yochum agreed to take the crash investigation while I took lead on the DUI investigation.

There was a 2005 Hyundai SUV bearing Florida License Plate IJUH70 facing south, perpendicular to the roadway. A female identified to me as Denise Yates was in the driver's seat of the vehicle. There was recently turned up grass tracks and dirt on the north side of the roadway and a large palm tree lying in the roadway. There was a crowd of approximately two dozen people in the area. Palm Beach County Fire Rescue was already on scene and speaking to Yates.

I walked up to the vehicle and made contact with Yates. Yates had bloodshot, glassy eyes. Yates appeared disoriented with delayed, uncoordinated movements. Yates had no visible injuries. I could smell the odor of an unknown alcoholic beverage on Yates' breath.

I took a sworn statement on my body worn camera from Len Elich, who witnessed the crash and saw Yates in the driver's seat. Elich walked up to the car where Yates was and confirmed that she is the same person he saw in the driver's seat immediately after the crash.

Yates was transported to the Jupiter Medical Center for medical treatment. Yates was obviously heavily intoxicated, with heavily slurred and mumbled speech and great difficulty coordinating her movements and slow, sluggish reactions. Yates began to take

her pants off spontaneously and was asked several times by medical staff to stop. Officer Yochum called me and advised that he located an open bottle of Vodka in the back of Yates` vehicle.

I read Yates her Miranda Rights from a prepared text. Yates advised that she understood, though she continued to appear to have trouble focusing. Yates was rambling incoherently with her voice trailing off. Yates began to try to take her medical probes and wires off in an apparent attempt to leave the hospital. At that point, I advised Yates that she was under arrest for DUI and placed her in a handcuff attached to the rail of the hospital bed. I advised Jupiter Police Dispatch that Yates was under arrest for DUI.

When medical staff had completed their initial evaluation, I spoke to Dr. Tanabe. Dr. Tanabe advised me that Yates would likely be in the hospital for hours as her BAC was almost certainly well over .300, the limit to admit someone into the Palm Beach County Jail. I determined then that obtaining a breath sample would be impractical or impossible and I would have to request a sample of Yates` blood. Yates was then taken to the CAT scan room. Yates drunk like behavior continued.

While I was outside Yates` room, Dr. Tanabe advised me that Yates` medical blood alcohol was extremely high and she would likely be in the hospital for many (eight plus) hours. I requested Yates provide a blood sample. Yates refused. I read Implied Consent for blood from a prepared text. At approximately 1911 hours, Yates advised that she understood and refused to provide a sample of her blood.

While at the hospital, Yates displayed mood changes. She pulled her IV line out with her teeth. Yates struggled hard against the handcuff on her right hand for an extended period. Yates was very demanding and repeated orders for me to call her boyfriend to pick her up. Yates asked dozens of times if she was going to jail and what for. Yates was confused when I told her she had crashed her car.

I did not record my entire interactions with Yates on my Body Worn Camera as I was in a medical facility and I was respecting the privacy of Yates and other patients as much as possible. This is consistent with Jupiter Police Department Policy. My investigation on scene was captured on body worn camera.

Once Yates was medically cleared, I transported her to the Palm Beach County Jail, where I charged her with DUI with Property Damage per FSS 316.193(3)(C)(1) and Reckless Driving with Property Damage per FSS 316.192(3)(A)(1).
