On February 9th 2018 at approximately 1722 hours D/S Amadon id #9440 and I were dispatched to report of a suspicious incident at 507 10th avenue north within the city of Lake Worth. Upon our arrival we met with a white male and white female subject. The female/victim was later identified by Florida driver license as Lisa M Mariott. The male subject was later identified by Florida driver license as Dennis Jason Lambdon.

Lisa told me that Dennis has been living with her in her rental property for approximately two weeks. Lisa and Dennis are living as roommates and do not have any romantic involvement. Lisa told me that Dennis has been abusing Xanax and that "he chews them like candy". While speaking with Dennis there was an apparent unknown white substance coating the top and bottom of his inner lip and edges of his mouth. Lisa advised in a sworn statement that Dennis became upset after waking up from a nap. Lisa said that Dennis began yelling "where is my Xanax you bitch". Lisa stated that Dennis punched her bedroom door and "pushed me down on the bed" while attempting to locate the Xanax he felt was in her possession. Dennis did have small cuts or abrasions on both hands on his knuckles. Lisa also stated that Dennis threatened to kill her dog while attempting to force his way into the bedroom. Dennis denied pushing Lisa down and also denied any physical encounter. Dennis could not explain the blood on his knuckles or an abrasion on Lisa. Lisa completed a sworn witness statement as it pertains to the facts above. Dennis was then placed into handcuffs that were double locked and checked for proper fit. Post arrest and prior to transport Palm Beach county fire rescue number 91 responded to evaluate Dennis vitals in reference to the possible ingestion of an unknown amount of Xanax or other unknown white substance. Palm Beach County fire Rescue advised Dennis vitals checked out and he was transported to Palm Beach county sheriff district 14 substation located at 801 N G Street in the city of Lake worth.

For the aforementioned facts I find probable cause to arrest Dennis lambdon for the charge of Simple Battery a violation of FSS 784.03(1)(a)(1). Dennis was turned over to D/S Desmond #9714 and D/S Chase # 31278 for transport to the Palm Beach County Jail located at 3228 Gun club road in unincorporated West Palm Beach, FL.
