On the 6 day of MARCH 2018 at 23:55 A.M P.M (Specifically include facts constituting cause for arrest.)

On March 6, 2018 at approximately 23:28 hours, I was on foot patrol in the area of 414 Lake Avenue in the City of Lake Worth, Palm Beach County, Florida.

It should be noted that this location is commonly referred to as the Cultural Plaza or City Hall Annex. This location is closed after 22:00 hours and clearly posted with signs. On the above time, I observed a white male who was later identified as Derrick Peterson walking through the center area of this location. Peterson appeared to be under the influence of an unknown substance and sweating. Peterson was stopped for investigative purposes due to being in violation of park hours and was cooperative. While searching Peterson, I recovered a red Marlboro cigarette box in his side pants pocket. Upon removing the cigarette box and further examining the inside, I discovered multiple white rocks which I recognized as Crack Cocaine based on my training and experience. I conducted a background check on Peterson and he had a past of drugs, failure to appear, and trespassing.

Peterson was placed in handcuffs which were checked for proper spacing and double locked. The white rock like substance was tested using a PBSO issued Cobalt test kit and tested positive for traces of Cocaine.

Based on my investigation, Peterson is in violation of F.S.S 893.13(6A), Possession of Cocaine.
